As residents of Shutesbury, we are very concerned about the safety of Lot O-32 now that the Town is planning to construct a new public building on the parcel. Recent problems in Springfield and Greenfield regarding the trustworthiness and accuracy of Licensed Site Professional (LSP) O'Reilly, Talbot, and Okun cast doubt on the 2021 assessment performed by that LSP for the Town of Shutesbury.

Community participation in the planning and execution of Immediate Response Actions ensures that the public interest is served through mutually beneficial interactions between citizens and government.
