We are rapidly closing in on May 6, 2017, the date for Annual Town Meeting. Your Select Board is busy finalizing the warrant. Many of the articles are standard ones that need to be voted/approved on an annual basis, but there are a couple that are different.

Every year we need to approve the assessment method used by the Regional School District to determine the share of the Amherst-Pelham Regional School budget each of the four towns (Amherst, Leverett, Pelham, Shutesbury) needs to contribute. The default method is the Statutory Method, created by the Department of Elementary and Secondary Education. However, regions are allowed to devise their own assessment method.

Such an Alternative Method has been used by the Amherst-Pelham region for 10 years. disadvantage when compared to the Statutory method. We have been discussing developing a more equitable method with the other towns for three years. Shutesbury's position is that the Alternative Method does not account for a town's "ability to pay" and that a revised method needs to take this into account.

Over the last few years we have adapted the assessment method to the point that this year the warrant article will ask that each town approve a method that incorporates an assessment based on 10% of what the Statutory Method requires us to pay, and 90% of the Alternative Method. Shutesbury is not satisfied with this assessment, but we have agreed to this for this year only. We continue to work with the other towns to have in place for Town Meeting in 2018 a method that meets our needs and is acceptable to the other there

Progress on the road to broadband

Shutesbury Broadband Committee

Over 100 people attended the March 28 Special Town Meeting and Broadband Information Session. In addition to a short presentation about the project status and next steps, voters decided in favor of creating a fivemember Municipal Light Plant Board (MLP). MLP's are what allow towns to own and operate their own broadband networks.

Recent legal clarifications have shown advantages in separating out the MLP from the Select Board. We believe this restructuring is the correct legal formation for an MLP, and will also help move the project forward faster. The Select Board fully supports this change, and its creation will not hold up the project in any **See Broadband**, page 4

Shutesbury's open **Town Meeting** is May 6, starting at 9:00am. All registered voters **may vote in person on warrant articles** as each item is put before its members during Town Meeting. You will receive town meeting materials in the mail and they will be posted on the town web site, <u>www.shutesbury.org</u> as soon as they are ready.

Registered voters may also **cast a ballot at the town elections.** Polls open from 8:00am – 2:00pm. Election results will be posted on the town website. The **Voter registration period** closes on Saturday, April 15 at Town Hall from 2:00 – 4:00pm and from 7:00 – 8:00pm. - voter's signature.

Alternatively, you can use the forms available outside the Town Clerk's office or online on the town clerk's web page. Please allow plenty of time for mailing application and ballot materials back and forth. You may also vote absentee in person at the Town Clerk's office until noon on Friday, May 5.

The schedule for other distribution dates and recycling will be available at ATM and on the home page of the town website. So, when you arrive at the Elementary School, in no particular order, you can pick up trash bags, sign in for a card for voting on Town Meeting articles, and check in for a ballot to vote.

Spring is also an opportune time to **license or re-license your dog** before the current license expires on June 30. We did not include the application in this mailing. Applications are now available on line, and outside the Town Clerk's office. They will also be on the information table at Town Meeting. Early birds can avoid a late fee by registering before August 1, 2016.

Note from the Town Collector Ellen McKay, *Town Collector*

Dear Shutesbury taxpayers, Happy spring! Now that the warmer weather is approaching, we are approaching the end of fiscal 2017 and the Town Meeting for fiscal 2018.

My office hours are Monday, Tuesday, Wednesday and Friday from 9:00am – Noon and Thursday from 8:00-11:00am. Should you need to see me and these times are inconvenient, please call and we can arrange a better time to meet.

Due to the time it takes for mail delivery, it is imperative that you <u>PLAN ACCORDINGLY</u> when mailing your payments. Under Mass. General Law, we do NOT use the postmark for date of payment but rather the date of actual receipt. You should mail bills at least <u>ONE WEEK</u> before they are due to insure that they are received before the due date.

If you use on-line banking from your bank (not the Town's system), please be aware that the bill will come to this office for processing from the lockbox because it is not accompanied by a copy of the bill. To make certain the payment is received on time, please change the mailing address to Town Collector, PO Box 175, Shutesbury, MA 01072 -0175. This will eliminate the bill going to the lockbox and being forwarded. PLEASE make sure the memo information is correct and does not reflect information from previous payments (ie: listing real estate or excise bill numbers from previous years or an incorrect type of bill). Since your bill payment is NOT an automatic transfer into the Town's bank account, you must PLAN ACCORDINGLY when authorizing the payment. DO NOT set up the payment on the due date, it won't get to the Town until almost a week later which will result in fees and interest.

Community clean-up

The Third Annual Community Clean-Up is scheduled for Saturday, April 29, from 10:00am – Noon, rain or shine. Friends, families and neighbors walk up one side of their road and down the other, picking up litter that has accumulated over the year. This is an opportunity for the community to help out their town.

In conjunction, student council 5th and 6th graders volunteer to clean up the schoolyard. It is never too early to give and receive the benefits of community service and take pride in our town. These efforts are much appreciated.

This year the trash drop-off site will be in the Highway Department yard. We will have a trash-only dumpster, provided as a community service by our trash hauler, restricted to the same items allowed in weekly trash pick-up. Containers and returnable cans can be collected separately in big recycle bins. For any town trash bags you use, we will replace it with a new bag. If you discover large, illegally dumped items, you can let us know its whereabouts.

Last year we covered most but not all town roads. Invite your neighbors to help make this a community wide effort. We'll have a map to show additional areas that might need some attention. If you looked at your calendar and said, "Oh, rats! I'm out of town on the 29th," you may find time earlier in the week to walk your road and pick up trash, making Shutesbury a nicer place to be.

Broadband, cont. from page 1 way. Elections for the five-member board will take place in 2018. For the coming year the positions will be appointed by the Select Board.

One positive recent development is that thanks to the advocacy work of many groups and individuals throughout the state, the Massachusetts Broadband Institute (MBI) is no longer in charge of the state grant money. Instead, towns like Shutesbury that wish to move forward with their municipally-owned build can receive their Last Mile funds directly to design, engineer and build their broadband networks. Shutesbury's share is \$870,000.

And there is actual progress being

made. We expect service to start in late 2018 or early 2019. Our pole surveys are nearly complete and makeready work performed by the utility companies to get the poles ready to accept fiber should happen this year, with construction planned for 2018. We know this timeline is later than expected. Please know that we've done everything in our power to get this done faster, but due to delays with the state grant process all towns that are part of the Last Mile build have been unable to move forward until now.

In order to operate our network once it is built, Shutesbury has two affordable and sustainable options. One option is the WiredWest Cooperative. At this time our research shows such a regionally operated network to be the most advantageous and costeffective option for our town. The other option is to run our network on our own, similar to what Leverett is doing by contracting with companies who will provide the necessary services.

We'll continue analyzing the options but the important point is that we can affordably own and operate our network. In the meantime, the build process will proceed since we need to get it built before it can be run!

You may have seen in the news that Shutesbury received two offers, one from Charter and one from Comcast, to supply broadband to our town. These private providers proposed to use our portion of the state grant monev to build, own and operate a broadband network. Our Select Board declined these offers for a number of reasons, including a lack of long-term stability and cost control, outmoded technology, and the potential for delayed timing. The most concerning issue with the cable offers was the lack of 100% coverage, since up to 40 households could have been left out without any service whatsoever. Our town leadership believes that in the 21st Century broadband is a necessary utility, not a luxury, so all households should have internet access just as we all have access to electricity, and police and fire services.

With our own network we have the opportunity to invest in our own telecommunications future and maintain control in such a way to act in our townspeople's best interests long into the future. Please stay up to date on the project at <u>www.shutesbury.org/broadband</u>

taxes are due May 1. I urge you to pay these bills promptly as the next bill you will be receiving is a demand that will cost you an additional \$ 5.00 plus interest. If you need to set up a payment arrangement on your bill, please contact me as soon as possible. Although interest will accrue on any overdue portion of the bill, you will avoid the additional interest and any collection procedures beyond the demand that will accrue should you leave the entire bill unpaid.

Don't forget to contact the Board of Assessors if you no longer have a vehicle on which you have received a motor vehicle excise tax bill. All bills should be paid in full before you apply for abatement. If this is not done and the bill becomes overdue with additional fees and interest before abatement, these must be paid along with any outstanding balance due on the bill after abatement. Payment of all types of bills MUST be received on or before the due date which is clearly marked on the bill. Please make note of these dates and make your payments accordingly. Always open all envelopes you receive from this office immediately on receipt. The bill you think is a real estate bill (and paid by your bank) may be an excise tax bill for which you are responsible.

Be sure to notify this office if you change your mailing address to avoid a delay in delivery of your mail which is returned to me for forwarding. This can take as much as two weeks which reduces the time you have to pay the bill on time.

Should a demand bill be issued on a motor vehicle excise tax, the law provides <u>14 days for receipt</u> of payment before a warrant for collection is issued to the Deputy Collector. This results in at least \$ 22.00 in additional fees. Upon mailing of the demand bills, payment of the original bill will NOT be accepted and checks made out in the incorrect amount WILL be returned to the sender.

Some of you have been unable to pay your bills on line. Once a bill is overdue, it is automatically deleted from the system and can't be paid on-line until the demand is issued. If the bill is on warrant, it cannot be paid on-line except through the Deputy Collector.

The week before each Bulky Waste Day is "Free-By-the-Side-of-the-Road Week." If you have items that you no longer need but might be useful to others, place them on the roadside during the week beginning Saturday May 27. NOTE: Items placed on the roadside that are NOT picked up before Bulky Waste Day must be removed at the end of the week. Put them in trash bags or bring them to Bulky Waste Day. Shutesbury has a "Littering and Dumping Bylaw" that addresses items left by the side of the road longer than two weeks. Recycling mercury-bearing waste at Town Hall

Mercury is a strange element. It is the only naturally occurring liquid metal, and it is incredibly dense. An iron bar will float in a bowl of mercury.

Alchemists thought quicksilver (mercury) was the key to the transmutation of lead into gold, and conducted experiments that entailed heating mercury (and, consequently, breathing its vapors).

For many years, mercury was considered a medicine, and, indeed, mercury does have antibacterial and antifungal properties.

It is also a potent neurotoxin. Hat makers in the 19th century used mercury in their trade, and the phrase "mad as a hatter" referred to people who showed the, uh, mercurial behavior of hat makers: aggressiveness, mood swings, inability to pay attention, etc.

Although we now know that mercury is bad for human beings, we continue to use it in many different ways in fluorescent lights, thermostats, some electrical switches, and even some of the tennis shoes that light up when kids run and jump — and some manufacturing processes still release mercury vapor into the atmosphere.

Another property of mercury is that it remains in the environment forever, and becomes concentrated in the food chain, especially in fish.

So, what do we do with mercurybearing waste?

For several years, Shutesbury residents have been able to drop mercurybearing items and rechargeable batteries off at Town Hall for recycling. When the containers at Town Hall fill up, we put the nasty stuff in the Universal Waste Shed out back.

Once a year, a company that processes mercury-bearing waste (by binding the mercury to inert material) picks up the waste and takes it off for processing. The Town has to pay for this service, of course, and you can save Shutesbury money by recycling your compact fluorescent bulbs at Home Depot or Lowes.

Here is a list of items that can and can't be recycled at Town Hall.

Fluorescent lamps of all kinds.
 Please no packaging, tape, bubble wrap, cardboard, etc. No broken bulbs and no incandescent bulbs; these can go in the trash.

- Thermostats, thermometers barometers. **No packaging, please.**
- Rechargeable batteries and button batteries. Place a few batteries in a baggie and place the baggies in the box under the table. No alkaline (regular, non-rechargeable) batteries; these can go in the trash.
- Cell phones. Just drop them in the green box.

Contact the Conservation Commission BEFORE starting your project The Shutesbury Conservation

Commission

Don't wait till until your contractor is scheduled to contact us. With the arrival of warmer weather, many town residents start to think about construction or landscaping projects. New construction, tree removal, grading or excavation, and almost any work done near Lake Wyola must be reviewed by the Commission before work begins. Keep in mind that the Conservation Commission must sign off on all **Building Permit Applications whenever** digging is required. At the minimum, a site visit is required prior to signing off. As a fully volunteer Commission, we often can't schedule a site visit for at least a week. And if wetlands are nearby, the process is more complex and takes several weeks.

Our knowledgeable clerk, **Linda Avis Scott**, is there to help you through the process. She can help you determine what you need to do and how to go about it. Here's how to start:

- 2. Visit Town Hall during Scott's office hours: Tuesdays and Thursdays from 10:00am to 12 noon.
- 3. Attend one of our meetings (from March to October, on the 2nd and 4th Thursdays at 7:00pm and from November to February, on the 2nd Thursday). It's best to call first to get on our agenda.

Developmental screening for 3, 4 and 5 year olds

Developmental screening is available through Shutesbury Elementary School as a first step in a process intended to find children in need of special services and to plan for meeting those needs.

The screening focuses on a child's growth in a number of areas, such as large and small muscle control, speech/language development and concept development. This activity takes about 40 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of whether or not a child's skills are developing within the typical range.

This screening is available to all families in town, including those with a child not already enrolled in the school's preschool.

and use them Sunset to Sunrise, and during periods of restricted visibility.

All vessels must have at least one USCG-Approved Personal Flotation Device ("PFD" or "life jacket") for each person on board. Children under 12 years of age must wear an approved "PFD" at all times. Approved "PFDs" must be worn by each person on board a canoe or kayak from September 15th to May 15th at all times.

Canoes, kayaks, boards, and sailboats must have navigation lights and use them Sunset to sunrise, and during periods of restricted visibility.

No swimming beyond 150 ft. from shore unless accompanied by a boat. Personal Watercraft (i.e. jet skis, wet bike, or surf jet, so-called) are PROHIBITED.

All motorboats must travel in a counterclockwise direction.

Lake Speed Limit is 30 mph during the day and Headway Speed (5 mph) from Sunset to Sunrise. Headway Speed (5 mph) at all times in either cove or within 150 ft of shore, and 75 ft of floats or markers that designate swimming areas.
