Hello Neighbors,

It's been a busy Fall and Winter for the Select Board. We have had very full agendas and multiple meetings in addition to our regular bi-weekly meetings. All of our meetings are "open" and available via Zoom or inperson. We adopted the "hybrid" meeting model last Fall and have chosen to continue that practice. Meetings are also all recorded and available on YouTube.

Here are a few highlights from our recent meetings.

Over the Fall/Winter we accepted the resignations of several residents who have given a lot to the town over the years.

Jeff Lacy, Miriam DeFant, and Gary Bernhard have resigned and been thanked by the Select Board on behalf of the town for their dedicated work.

**JoAnn Bernard** has resigned as Co-Chair of the Council on Aging. We thank her for her work also.

We also appointed **Ashleigh Pyecroft** as full member of the
Planning Board, **Curtis McGuire** as full-time Police
Officer, **Elizabeth Murphy** as a

Library Trustee, and **Sean Genereux** as the new Recycling Coordinator.

We also would like to thank **Jon Thompson** for stepping up to chair the Zoning Board of Appeals.

We are happy to report that the **Locks Pond Culvert** project is finally completed. Severe weather last summer delayed the project's completion. We appreciate everyone's patience with the traffic detours. We are also happy that construction of our **new Library** will, in theory, start soon.

There are several other initiatives that we were tangentially involved with. The **Subduing Knotweed Coalition** met with us to discuss the persistent growth of the invasive species Knotweed in town. We appreciate the work done on this and anticipate a proposal in the future. **Mary Jo Maffei** is leading this effort and can be reached at maryjomaffei22@gmail.com or 413-265-6390.

We also met with the **Historical Commission** to discuss the town common guideboard's needed repairs. As of this writing, using CPA and Historical Commission funds, the guideboard has been transported to Williamstown for restoration.

One of our ongoing issues was the Attorney General's (AG) rejection of our 2023 "Solar By-

law" and the subsequent lawsuit against the town by Cowls and Puresky. The lawsuit is still in court, so we are not at liberty to discuss this in great detail. We have had several Executive Session meetings with our legal team and the **Planning Board**. Suffice it to say this is far from over. Stay tuned.

Perhaps the biggest event in the recent past was the Conservation Commission's adoption of new regulations and the town's adoption of a **new Wetlands Bylaw** (replacing our 1980's vintage bylaw) at our Special Town Meeting on January 23, 2024.

Conservation law and regulation is very complicated. It can be very controversial as well.

To aid in the completion of this project, the Select Board appointed **Gregor MacGregor**, who is a prominent Massachusetts conservation law lawyer. With his assistance, we hope the town has a new Bylaw and related regulations that we can all live with for a long time. Our thanks to the Conservation Commission for all their hard work on this.

## School Committee News Bethany Rose, Chair

Fall 2023 and Winter 2024 were a busy six months for the Shutesbury School Committee.

With the pending retirement of Superintendent **Jennifer Culkeen** after nine years of service, the Union 28 Joint Supervisory Committee, of which Shutesbury is member, was tasked with finding a new superintendent.

On February 16, three finalists interviewed for the role of superintendent. The Joint Supervisory Committee unanimously voted to hire **Shannon White-Cleveland**. White-Cleveland is currently the Principal at the Athol Community Elementary School and has 25 years of educational experience in both classroom and school administration.

In addition to taking part in the search for the new superintendent, members of the School Committee have also been part of many meetings discussing the upcoming elementary school budget, which includes negotiations with the Shutesbury Elementary Educators and Shutesbury Affiliated Workers.

Budget meetings have also extended to four town meetings with Amherst, Pelham and Leverett to discuss the Amherst Regional School Budget.

The School Committee approved the Elementary School's proposed budget, which continues all the services currently provided. While the negotiations could potentially affect the budget, we are optimistic that there will be no changes needed in the levels of services or offerings.

At the Elementary School, we were pleased to learn in January that some of our students received a Student Achievement Award from the Department of Elementary and Secondary Education.

The Department issued these awards to honor high-achieving, high-needs students throughout the state who exceeded expectations on the 2023 MCAS in English Language Arts or Math.

## Library Board of Trustees (two-year term)

Report on the Shutesbury Library Building Project Exciting happenings with the new Shutesbury Public Library!

Through the fall and winter, we have been getting deep into the details of our building design making both small and large changes always keeping in mind our goal; to provide a library that meets our residents' needs while being mindful of the budget. We have now completed the Design Development phase. Our architects are preparing Construction Documents which will be sent out for contractor bids in April. We're very excited about the final design. You can find the link for the latest Power Point presentation titled Updated Building Plans 2/2024 at the bottom of Library Building Committee webpage at https:// www.shutesbury.org/librarybuilding

In the meantime, we have held meetings with town boards and department heads to review the current plan. The Board of Health has permitted our septic system, and the Conservation Commission has approved the Order of Conditions for our construction work. The Police Chief, Fire Chief, Highway Superintendent and Town Administrator have all given feedback that has helped us refine our plan.

The new Library's well will be a public water supply, permitted by the Massachusetts Department of Environmental Protection. We have hired a well driller and are working with our well engineer from Fuss & O'Neil to complete the required testing and permitting. If all goes as planned, you will be seeing signs of the well drilling by the end of March. Thanks to our Highway Superintendent for helping with this process.

#### From the Recycling and Solid Waste Committee

Hard-to-Deal-With Stuff Although there is a lot of information about recycling and trash disposal on the RSWC website (www.shutesbury.org/recycling), we've recently had questions and issues come up about hazardous waste, sharps (needles), and nuclear medicine.

#### On the RSWC Website

If you're not sure what to do with an item, the first stop is the

RSWC website.

The **Recyclopedia** is maintained by the Mass. Department of Environmental Protection, and has information about what's recyclable, what goes in the trash, and what is hazardous waste. Just type in your item, and you'll get an answer.

Beyond the Bin is another DEP website that focuses on what to do with larger items such cidents involving nuclear medias textiles, furniture, mattresses, etc. Also on our website, at the top of the page, is "How do I get rid of..." a list of what to do with many items.

#### **Hazardous Waste**

Every year in September, Amherst offers a Household Hazardous Waste disposal day. Shutesbury residents can get rid of hazardous waste at this event, and someone from the RSWC volunteers, saving Shutesbury a few hundred dollars. Registration since the truck involved can't be for the event is mandatory, and information about the registration on, the hauler charges the Town process and what you can and can't bring to the event will be available here: Recycling - Solid Waste | Amherst, MA - Official website (amherstma.gov).

If you need to get rid of hazardous waste right away, there's a disposal location in Westfield, NEDT. Information about NEDT is at this website: NEDT Household Hazardous Products Collection Centers & Pick-Up. NEDT is open Mondays and Wednesdays 9am - 4pm and Saturdays 9am -1pm.

#### Sharps

If you use medical injections at home, the "sharps" — needles, syringes and lancets - can't be put in the trash. They must be disposed of at a special site. Amherst has a Safe Needle Disposal program. Residents of Amherst, Pelham, and Shutesbury may purchase "sharps"

containers at the Amherst Transfer Station.

The fee is \$5 per 2.5-quart container that includes the disposal of the filled container with a licensed medical waste hauler. Simply return your filled container to the Transfer Station.

#### **Nuclear Medicine**

Last year we had a couple of incine. Every truck carrying trash for disposal in Massachusetts must pass through a nuclear waste detector before the trash can be unloaded. If radioactive material is identified, the Department of Environmental Protection is contacted, and someone from the DEP is sent out to investigate. The trash can't be unloaded until the nuclear material is located and removed.

It costs the Town \$1000 each time the DEP is called in, and. used while this process is going \$300 for each day the truck is out of commission. Whew!

Nuclear medicine is used in several situations, mostly as a cancer treatment. Standard procedure is to isolate the material for 90 days, then put it in the trash. However, in one of the Shutesbury situations last year, the patient waited the 90 days as directed by the physician, but because it was a new form of nuclear medication, it apparently had to be sequestered for more than 90 days and triggered the detector. So, if you're using nuclear medication, make sure you get all the facts from your physician about its disposal.

What is Digital Equity? by the Shutesbury Broadband Committee

In short, digital equity is ensuring that every person has the information technology resources to fully participate in society, democracy, education, healthcare, and the economy.

Shutesbury has already done the hardest part of ensuring digital equity in a community by making high-speed broadband service available to every household and business. If you live in Shutesbury, the network is available to you!

The next part of digital equity is making sure that service is affordable and people have the devices they need to access the internet. Digital equity will also help ensure people understand how to optimize the use of their electronic devices for healthcare, education, and remote work, while at the same time staying safe on the internet.

Over the next several months we'll be reviewing regional data and gathering information from a townwide survey as part of a Digital Equity Planning process. Shutesbury has been awarded a grant to partner with the Franklin Regional Council of Governments (FRCOG) and the Town of Leverett to design and distribute the survey. The results of the information we gather will help identify the digital equity gaps in Shutesbury and put us in the eligibility pool for \$147 million in state

ggrant funds. If awarded, these funds could be used for network equipment upgrades, router upgrades, and educational programs.

Stay tuned as we continue to work to make Shutes-buryNET affordable and useful for all townspeople who want to use the internet.

Enjoying Spring Together! On March 10, the Recreation and Open Space Committees co-sponsored their first of two walks at Ames Pond. This land, bequeathed to the Kestrel Land Trust by Julian Janowitz, is an extraordinary landscape of wetlands and forest. Although rain threatened throughout the week, sun broke through periodically, and most important, no rain. The walk was led by Graeme Sephton, whose good cheer eclipsed any concerns about the mud and slush along parts of the trail.

Graeme frequents the area and shared his knowledge about the trails and the history and flora and fauna of the area. The walk also provided a great opportunity to get to know new people.

Our committees' next cosponsored walk will be in May or June. For those interested in hiking there, please be aware that construction and reconstruction of the boardwalk is ongoing and avoid areas where the old boardwalk is submerged and/or where construction is occurring.

Our next event was cosponsored with the Library for April 7. Library Director **Mary Anne Antonellis** planned an eclipse craft program on the day before the upcoming solar eclipse, with supplies and instructions to make eclipse viewers. In keeping with our eye on the sky, we invited people to come fly a kite with us! If they didn't have kites, we would have some. We hope that you were able to attend!

We also have events in the works to be co-sponsored with the Library, but with no firm date as of this writing.

First, we plan to offer a mushroom growing workshop that will give participants the information they need to decide if mushroom growing is for them. This event will likely be held end of April or early May. Second, we will have two evenings for star gazing led by Tom Schieding. Third, we will be sponsoring a birdwatching event in mid May to correspond with peak bird migration. Please look for emails from the Recreation Committee or Library for additional information on date, time, and location.

The Recreation Committee is pleased to be a sponsor of an **Artist Studio Tour** to be held on Sunday, June 30. Organized by **Joan Green**, there will be many studios participating. It will give visitors an opportunity to visit local studios, talk to the artists, and become familiar with their work. It will be a wonderful celebration of our local artists.

The Recreation Committee is looking for a new chair. Barbara Bigelow plans to step down at the end of June. If interested, email her at Recreation@shutesbury.org. As you can see from this submission, the Recreation Committee sponsors diverse, interesting, and fun activities. The total time commitment is 6-8 hours a month, including a monthly meeting.

## Community Preservation Committee Update

This year the Community Preservation Committee (CPC) welcomed two new members: **Beth Willson**, as representative for the Conservation Commission, and **Clif Read**, as designee for the Planning Board.

As a Community Preservation Act (CPA) community, Shutesbury receives a match of additional funding from the state Community Preservation Trust Fund each year based on the previous year's local surcharge revenue. Shutesbury raised \$53,599 from last year's CPA surcharge, so the town's FY24 distribution from the state Trust Fund was \$11,269.

This past fall the CPC began a process of evaluating community housing project ideas beyond only the construction of affordable housing. Some of the avenues being researched have included the creation of an affordable housing trust fund to administer programs for rental assistance or down-payment assistance. The Committee has also looked into the possibility of partnering with a neighboring community, such as Leverett, to develop a more regional program. No action has been taken on either of these ideas, but the Committee is interested in exploring and considering as many options as possible to better meet the statute's community housing goals.

In December 2023, the CPC received Determinations of Eligibility for two potential projects considering seeking Community Preservation Act funding, both of which were determined by the Committee to be eligible. Neither project, however, subsequently submitted a full application for funding and so there will be no new CPA projects presented to Annual Town Meeting in 2024. The CPC will, however, be presenting its two usual warrant articles relative to the management of the Town's CPA accounts and

the Committee's annual administrative costs.

Since 2011, CPA funds have been used to support 14 projects around Shutesbury, amounting to over \$294,000 of direct investment—and hundreds of thousands of dollars more in matching funding—for historic preservation, open space, recreation, and affordable housing needs in the community. These projects are proposed by members of our community and our neighbors and represent key partnerships between town and regional committees, boards, and commissions, groups organized by Shutesbury residents, and area nonprofit organizations.

From the Assessors' Office

Personal Property Values: If you own a home other than your primary domicile, operate a small business, or raise farm animals in Shutesbury, and did not receive a Form of List to complete and return, please contact the Assessors' office. When personal property owners do not self-report the values of their personal property, Assessors must estimate values. A Form of List completed by the personal property owner provides Assessors with accurate value information.

New Growth: As Spring approaches, Assessors are tasked with identifying and valuing Shutesbury's "New Growth" since July 1 of the previous year. This means that any new construction such as new homes, additions, renovations and secondary structures, as well as demolition activities will be valued by means of "drive-by" or physical inspections, and property records

will be updated for the coming fiscal year. If an interior inspection is desirable, Assessors will request a voluntary appointment. Though property owners are never required to let Assessors onto their properties, it is the best way to achieve accurate valuations.

**Exemptions:** The various corresponding exemption application forms available to the citizens of Shutesbury will be mailed out, during the summer, to low-income seniors, blind citizens, and Veterans with 10% or more disability, as are known to the Assessors' office. The applications can be completed and submitted at any time before their varying submission deadlines. Anyone seeking more information concerning eligibility, or wishing to request a particular application to be mailed. should contact the Assessors' office by phone: 413.259.3790, email: assessor@shutesburv.org. or pick-up in person, by stopping in during office hours.

Chapter 61, 61A and 61B:

Reminder notices for the 10-year Ch 61 renewals, and the annual applications to continue Ch 61A and Ch 61B land classification status for FY 2026 will be mailed out during the summer. The applications are due in the Assessors' office no later than December 1. Owners of classified land, who no longer wish to continue their classification should notify the Assessors' office of that decision, for instruction for release of their liens. Early submission of Chapter 61 applications is always welcomed.

Motor Vehicle Excise: In conformity with Massachusetts state law, cities and towns receive their excise data from the Massachusetts Registry of Motor Vehicles (RMV). Therefore, it is very important for motor vehicle owners to contact the Registry of Motor Vehicles within 30 days of moving, to update their mailing address, and the place of garaging

of their vehicles. These updates can be made at the RMV website.

Many owners are surprised to see the high amounts of their new car excise tax bills. An excise at the rate of \$25 per \$1,000 of valuation is levied on each motor vehicle in Massachusetts regardless of the town. Value figures for the vehicles are based on the manufacturers' list prices for vehicles in their year of manufacture. The excise tax law (M.G.L. c.60A, s.1) establishes that only the manufacturer's list price and the age of the vehicle are considered. In the first model year vehicles are valued at 90% of the manufacturer's list price. By the 5<sup>th</sup> year, the value of the vehicle drops to 10% of the manufacturer's list price and remains there in succeeding years. Because of the everincreasing values of new cars, the amount of excise tax is becoming an increasingly important consideration for new car buyers.

## Note from the Town Collector

Dear Shutesbury taxpayers,

Happy spring! Now that the warmer weather is approaching, we are nearly at the end of fiscal 2024 and the Town Meeting for fiscal 2025.

IMPORTANT NOTICE: With the new computer system, the TOP section of the

bill is to be returned with your payment, and the middle and bottom sections are the copies for you to keep. Sending the incorrect portion of the bill to the lockbox (Woburn address) results in a delay of recording your payment because the coding is missing and they can't handle your payment. If you want a receipt, please send the entire bill (or the top and bottom sections) with a self-addressed, stamped envelope.

My office hours are Monday, Tuesday, Wednesday and Friday from 9am - Noon and Thursday from 8am -11:00am. If you call during these hours and I don't answer, please leave a message. I'm either on the telephone or have stepped out of the office.

Always open all envelopes you receive from this office immediately upon receipt. The bill you think is a real estate bill (and paid by your bank) may be an excise tax bill for which you are responsible.

If you use on-line banking from your bank (not the Town's system), please change the mailing address to Town Collector, PO Box 175, Shutesbury, MA 01072-0175. Please make sure the memo information is correct and does not reflect information from previous payments (i.e., listing real estate or excise bill numbers from previous years or an incorrect type of bill). Since your bill payment is NOT an automatic transfer into the Town's bank account, you must plan accordingly when authorizing the payment. DO NOT set up the payment on the due date as it won't get to the Town until almost a week later which will result in fees and interest.

If you are having financial difficulty paying your real estate bills, please contact me to arrange a payment plan.

Don't forget to contact the Board of Assessors if you no longer have a vehicle on which you have received a motor vehicle excise tax bill. All bills should be paid in full before you apply for the abatement. If this is not done and the bill becomes overdue with additional fees and interest before abatement, these must be paid along with any outstanding balance due on the bill after abatement.

Be sure to notify this office if you permanently change your mailing address to avoid a delay in delivery of your mail which is returned to me for forwarding. This can take as much as three weeks, which reduces the time you have to pay the bill on time. I am glad to forward bills if you are temporarily away. However, I must know this is the situation before you leave to avoid the bills being returned as "temporarily away" by the post office, which delays delivery to you.

Should a demand bill be issued on a motor vehicle excise tax, the law provides 14 days for receipt of payment before a warrant for collection is issued to the Deputy Collector. This results in at least \$22.00 in additional fees. Upon mailing of the demand bills, payment of the original bill will NOT be accepted and checks made out in the incorrect amount WILL be returned to the sender.

Some of you have been unable to pay your bills on-line. If the bill is on warrant, it cannot be paid on-line except through the Deputy Collector's office, which can be reached during business hours at 413-527-2388.

ponents of a good education system. Early experiences in an environment rich in hands-on materials and activities provide children various opportunities to grow emotionally, physically, socially and cognitively.

We believe that a transdisciplinary team approach, in which all adults working with children are responsible for a child's learning, is the most effective way of teaching, and we also believe that parents are the most important teachers of their children and that their involvement in their child's education is essential.

Your child must be 3 years old on or before September 1, 2024, for pre-school enrollment, or 5 years old on or before September 1, 2024, for kindergarten enrollment.

## Developmental Screenings for 3, 4 & 5 Year Olds

In Shutesbury, developmental screening is available through the school as a first step in a process intended to find children in need of special services and to plan for meeting those needs. Screening focuses on a child's growth in a number of areas, such as large and small muscle control, speech/language development and concept development.

This activity takes about 40 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of whether or not a child's skills are developing within the typical range.

## Where Did the Town Guideboard Go?

Many of you may have noticed the disappearance of the Town Guideboard off the Common this winter. The good news is that it has been moved to the Williamstown Art Conservation Center, to begin restoration of the historic structure. The MA Historical Commission lists the date of the original Guideboard as 1837, making it almost 200 years old.

The Shutesbury Historical Commission has been working on finding an affordable option for the restoration, and after considerable research by former member **Miriam Defant**, the Williamstown Center was determined by the Commission to be the best choice.

On a cold day in January, Historical Commission member Matteo Pangallo, with the help from local volunteers Daniel Lass, Paul Lyons, Clif Read and Al Werner, worked to get the

fragile structure wrapped and protected for the trip. Matteo drove the Guideboard to the restoration center. It will be a few months before the Guideboard will be stabilized, inspected and the next steps in rehabilitation treatment determined.

Funding for this project is from a CPA (Community Preservation Act) grant, the Historical Commission, and the Friends of the Historical Commission.

Libraries Transforming Communities: Accessible Small & Rural Communities The M. N Spear Library is honored to have been chosen as one of the 310 libraries for the second round of Libraries Transforming Communities: Accessible Small and Rural Communities, an initiative by the American Library Association (ALA). This initiative aims to provide small and rural libraries with the necessary resources for community engagement and accessibility, particularly for individuals with disabilities.

Through this competitive selection, the Library has been awarded a \$10,000 grant, which will contribute to creating an inclusive environment for community members experiencing neurodiversity, particularly children. This funding will play a crucial role in furnishing and equipping the new Shutesbury Public Library, ensuring that its spaces, collections, and ongoing programs consider the needs of neurodiverse individuals.

The engagement of neurodiverse community members and their families is important to the success of this project. Later this spring, we will be planning a community conversation with people whose lives are touched by neurodiversity to gain insights into how the grant can best enhance the resources and environment of


#### Blackout Poetry and Art with Jeannette Stockton Wednesday, May 15 at 6:30pm, Town Hall – for teens and adults
