EDUCATION STUDY COMMITTEE next meeting is **Monday, December 20, at 5 to 7pm**, at the Shutesbury Elementary School with Amherst Regional Superintendent Maria Gyrek.

NEW SHUTESBURY LIBRARY FUNDRAISING COMMITTEE voted on Monday to hire a fundraising consultant, Financial Development Agency, FDA, for \$7000. The costs for the consultant are being shared between the Friends of the Library and Trustees of the Library.

FIRE STATION CLEAN UP We have received more estimated numbers for the remediation underneath the rescue bay. This set calls for \$65,000 for installation of SVE, soil vapor extraction system that pulls the vapors from the ground and incinerates them. The waste is deposited in containers and removed. The estimate for one year of maintenance is \$35,000. These are all guest-i-mates. We need to commit to the project and set it up putting in a pilot system. Adjustments will be made as they determine the actual quantities of contamination and flow through the system. The Fire Chief, Selectboard, Building Committee and Finance Committee are evaluating at all possible options.

LFNAC members are entering edits made by their Editor/Proofreader, Jen Davies. Draft 10 will be handed off to 3 highly qualified volunteers who will be reading the grant for content and will make recommendation. This Committee is razor sharp and continues with one goal in mind, obtaining \$1.9 million in grant funds from the state, MBLC, to make this project a possible for Shutesbury. The application will be submitted in January 2011.
