FIRE STATION UPDATE The Selectboard, Fire Chief and Town Administrator met with their OTO consultant and Springfield DEP on Monday morning. The purpose of the meeting was to evaluate if the SVE technique as an effective tool. There was active brainstorming by specialists that helped us develop a ranking of the suggested remediation strategies. The SVE soil venting extraction that we ran as a pilot test declines in effectiveness under wet conditions. That method dropped to the bottom of our list. Our goal is to remove an additional 300 gallons of gas that possibly still remains under the firehouse. We discussed an injection method that our consultant is evaluating for safety and effectiveness for our particular project. The injection method is not restricted by the water table, a positive. But until we learn more about the safety concerns, required applications and cost it we don't know how to evaluate it.

WIRED WEST UPDATE The Wired West Cooperative Board met in Monterey, MA, October 15, 2011. The top priority at this point is the pole count and reconciliation with GIS data. Jim Drawe, WiredWest finance committee chairman, is spear heading the project. If you have expertise with GIS mapping and would like to assist with the project please let me know and I will get you contact information. Sub committees reported on Outreach, Technology, Governance, Marketing, Finance and Fundraising. If you know of people who would like to make donations please I can forward the information to the fundraising committee.

MBI UPDATE MBI, Massachusetts Broadband Institute is knocking at the door. G4S, a contractor, who will be running fiber optic cable into Shutesbury, stopped by my office today to get contact information for requesting details and trench permitting information if needed. He estimated that they would begin running wire in Shutesbury by springtime.
