a. Meet with Police Chief on budget: 7 p.m.

Presentation by the police chief of the FY11 budgets, one with 0% increase and one with -5%. He reviewed all budget areas. The Commonwealth Quinn Bill Policing Grant is gone starting next year which impacts the police budget at the current year rate by \$8,064. With it gone next year the town will need to cover the entire amount, not just half of it (approximately \$3,500). If cuts are needed he will reduce shifts to make budget.

b. Meet with Fire Chief on budget: 8 p.m.

Presentation by the Fire Chief of the FY11 budgets, one with 0% increase and one with -5%. He reviewed all budget areas. He would achieve the -5% funding by reducing \$1770 in operating and \$823 in Equipment. The committee noted that he needs to represent a budget that demonstrates 0 and -5% in personnel as well. He is going to return another time.
