Amherst Transfer Station & Recycling Ctr., Route 9, Amherst, MA

This form is for use by residents only. Businesses and Institutions may call the Amherst Department of Public Works at 259-3050 Ext. 0 to schedule an appointment or to obtain information about participating in the HHW collection.

Dispose of your household hazardous wastes safely! Residents of Amherst, Pelham & Shutesbury may participate. Sign up today for your HHW Day appointment.

No more than 25 gallons or 25 lbs. (whichever is greater) will be collected per household. Used motor oil, car batteries, fluorescent bulbs (\$1 each), & rechargeable batteries are NOT counted toward this limit. Amherst, Pelham, & Shutesbury residents with valid vehicle stickers may bring these items to the Transfer Station on Tuesdays, Thursdays and Saturdays, 8 AM to 2 PM.
