

Complex matters coming to Town Meeting

Two important school issues are looming on the horizon and will require voter input as early as Town Meeting this May.

One is adjusting the method used to determine regional assessment. The other is regionalization.

When it comes to determining assessments for regional school district expenses, the Massachusetts Department of Elementary and Secondary Education (DESE) allows regions to use a formula created by DESE (Statutory method) or a formula agreed to by the towns in the region (Alternative method). For the past eight years the Amherst-Pelham Regional School District has used the Alternative method.

Three years ago at Town Meeting, a resident made the observation that Shutesbury has been assessed about \$200,000 more under the Alternative method than we would have under the Statutory method and requested the town look into this.

This was brought to the Regional School Committee, which formed a working group of members from the four towns to evaluate the Alternative method and determine whether this was the best way to assess expenses. The group concluded the Alternative method was best. However, Shutesbury felt their concerns hadn't been addressed and felt the process leading to the group's conclusion was flawed.

Shutesbury's Finance Committee recommended the Select Board form a Shutesbury Regional Assessment

Summer Study Committee (SRASSC) in an effort to reevaluate the assessment method.

The committee spent the summer of 2015 analyzing data regarding wealth, income levels, enrollment, demographics, tax rates, and other aspects of a town's ability to pay their assessment.

The committee produced a report that confirmed that Shutesbury's ability to pay (property values, income, economic status) was less than the other towns' abilities to pay. The report also showed the Statutory method takes into consideration ability to pay and because of this, the Statutory method is a better formula to use.

While the Shutesbury Summer Study Committee determined that the Statutory method is the most equitable, transitioning to its use in one year has large effects on each town's finances. With a total assessment of 19 million dollars to be spread among the four towns, going directly to the Statutory method would mean the assessment for Pelham and Shutesbury would be reduced by about \$200,000, while the assessment for Amherst would increase by

There are 351 Cities and Towns in Massachusetts. Shutesbury's State Assigned Number is 272.

The Mass Municipal Association (MMA) holds an Annual Conference and Trade Show in Boston at the end of January every year. The MMA supports cities and towns across the Commonwealth of Massachusetts.

It lobbies for cities and towns at the state legislature on matters important to us. It informs the towns about political initiatives that occur and explain how they impact municipalities. It holds forums on emerging issues like the Opioid Epidemic and the Share Economy. Twenty workshops were presented, ranging from Labor Law Updates to Economic Development for Small Towns.

It is at the conference where you can meet and talk to decision makers from all over the state. How do you deal with social media? budget presentations? tasers? historic preservation? health issues and trash collection? cable franchise services, and last mile Internet?

papers, get them signed and returned by Saturday, March 19. (See related articles on pages 3 and 10 about appointed seats and other volunteer opportunities.)

Vote: Local, State and Federal elections

Voter registration forms are available at the Town Hall or the Town Clerk will mail you one. You can also get the form on line (or at the library if you don't have Internet). Party affiliations or address changes all must be done 20 days before the state or federal elections, or 10 days before the town elections. Don't delay register today!

Absentee ballots are available for those who are unable to come to the polls due to health concerns, religious restrictions or because they will be out of town on Election Day. Contact the Town Clerk for information about getting an Absentee Ballot Application and ballot.

Election Worker Pool. This will be a busy year for elections; a good year to broaden our town's election worker pool. If you have never participated in this activity, let the Town Clerk know of your interest. It pays the hourly minimum wage and there are different time slots available throughout the day from 7:45am -8pm as well as evening hours to count the ballots. Try it - you might like it.

2016 Elections Schedule:

March 1: Tuesday. Presidential Primaries (Don't we know it!) -Town Hall

May 7: Saturday. Town Elections at Annual Town Meeting; polls open 8am - 2pm at Shutesbury Elementary School

Get Counted:

Annual Census. Did you get this year's blue Annual Census/Street List form?

This is part of an important process required by the state. The information is used as proof of residency to protect voter rights and veteran status, and it helps our schools with enrollment information and projec-

Registered voters are maintained as "active" if their form is mailed back to the Town Clerk.

Census data is used to update the annual street list available to our police chief and our fire chief/ emergency management director as they carry out their public safety responsibilities.

Census information about children under the age of 17 is not made available to the public.

Notice to the Voters of Shutesbury Winter 2016

Two general by-laws approved at the May 3, 2014 Annual Town Meeting have been approved by the Office of the Attorney General.

Article 18 amended the Town's "Watercraft and Persons Using Lake Wyola" by-laws to read:

- 2. Speed Limit on Lake Wyola is not to exceed (30mph) day time and 5 mph Sunset to Sunrise.
- 5. No water skiing between Sunset to Sunrise.

This by-law change was also approved by Colonel James McGinn of the Massachusetts Environmental Police.

Article 19 adds to the Town's general by-law a new, unnumbered by-law "Littering and Dumping." Section 4 provides that the by-law may be enforced through non-criminal disposition and further provides in relevant part as follows: B. If materials are not removed within the two week period after notification, a fine of \$25.00 in addition to all costs of

disposal, including waste removal and disposal costs, Shutesbury departmental, administrative and hired staff time to handle the disposal, and any other relevant costs incurred, shall be charged to the violator.

Copies of these two by-laws are posted at the Locks Pond bulletin board, the Town Hall, the Library, the Shutesbury Post Office, the Shutesbury Elementary School, and the Cross Road bulletin board.

This year 500 town officials, selectmen, administrators, mayors, city councilors gathered.

We heard the governor speak. He listed the local financial assistance that he is recommending be distributed to cities and towns. Shutesbury aid will increase by \$2,360 for the elementary school and our unrestricted lottery aid will increase by \$6,722.

Cherry sheet revenue, state funding that comes to the towns, will remain mostly flat. So the state is holding steady for this year.

He underscored his efforts to address his greatest concern, the Opioid Epidemic, which is leaving no community untouched.

I heard the Springfield Chief of Police, John Barbieri, say every day in his city there are two heroin overdose deaths. The Governor is promising more beds for treatment, new programs and more support.

The news from Senator Elizabeth Warren was that the federal government is remaining open for business this year, not shutting down. And the second piece of good news is that there are few cuts and a few minimal gains in grant funding for things like "Meals on Wheels" in the federal budget this year.

criticized the Wired-West business plan. MBI is a governmental organization responsible for contributing 1/3 of the build costs and managing the build process across the state.

In an effort to resolve the issues, the WiredWest Cooperative continues to meet with the MBI. There have been multiple meetings since mid-December and both parties are working hard to negotiate issues around ownership and the operating structure so the project can move forward.

A positive result of the release of the December 1 statement has been an increase in press coverage and more public involvement.

As a result of the attention and a desire to find common ground, communication between WiredWest and the MBI has improved and both sides have a renewed commitment to work together towards the goal of bringing

In addition, our legislators increased their involvement and Wired West has met with them to make sure they are informed and support the

> We have done extensive research for close to two years and our investigation still shows that the WiredWest solution offers more benefits than the other solutions available to us. We will continue our thorough review of all information as it is released. We're planning a second full review of the revised operating agreement

and financial model in February to make sure that the WiredWest solution continues to meet our needs as a town.

The Shutesbury Broadband Committee is in ongoing contact with the Wendell and New Salem Broadband Committees. We have plans for special tri-town sessions in 2016 to further foster communication and information sharing in the coming year between our neighbor towns.

New Hires for Union #28
The 2015 school year started with some new leadership at Union #28.
We'd like to welcome **Jennifer Haggerty** as our new Superintendent. Jennifer comes to the Union with 28 years of experience in public schools — 20 years teaching kindergarten, and the last seven years as an elementary principal in Orange.

Aaron Osborne is the new Director of Finance and Operations; he has 15 years of experience, previously holding the Director of Finance position with the Southbridge public schools, and has also taught middle and high school math for six years.

Budget

The 2016-17 elementary school budget is projected for a 1% increase. This includes some grants we've received in prior years, but which may or may not be funded this year. If none of these grants come through, the worst case is a 2.28% increase.

The town's Union #28 cost allocation is expected to be a 10% decrease.

Advocacy

School Committee members are advocating to address concerns from the public regarding high-stakes, standardized testing and the impact of charter schools on small and rural districts. We are working with our state representatives and organizations that we are members of, including MASC (Massachusetts Association of School Committees) and CES (Collaborative for Educational Services).

The School Committee meets the 3rd Thursday of every month, 7pm at the elementary school. Meetings begin with an opportunity for public comments and questions; everyone is welcome — but not required! — to stay for the entire meeting. Note: due to school vacation, the February meeting is the 4th Thursday, February 25.

Students are immersed in rigorous and engaging literacy learning. Classrooms are also using the Words Their Way program for spelling and word study. These programs are robust and hands-on, with lots of room for differentiated instruction and imagination.

Classrooms are continuing to offer great field trips that let our students see and explore theater, movie making, nature, and their community. Regional School District updates

The FY17 Regional School budget has been released and Shutesbury's assessment is \$1,727,118, an increase of \$71,682 or 4.3% over FY16.

The Regional School Committee has voted to change the current trimester academic schedule at the Amherst-Pelham Regional High School to a four-semester schedule beginning with the upcoming 2016-2017 school year. There are also initial discussions with the superintendent and her staff about combining the Regional Middle School (grades 7-8) with the Regional High School (grades 9-12).

The superintendent has given two main reasons to consider consolidation, declining enrollment throughout the region and yearly cost savings of approximately \$800,000 per year. The earliest that this would take place is the 2018-2019 school year.

Note from the Town Collector

Dear Shutesbury taxpayers,

With the winter upon us, the third quarter of our real estate bills have become due and the calendar 2016 motor vehicle excise bills for many vehicles registered on January 1 have been mailed. Additionally, excise bills on vehicles registered late in 2015 are billed during 2016. The year for which the bill is issued is found in the upper right hand corner of the bill.

If you receive a bill on a car you have traded or on which you have changed registrations, do NOT ignore the bill. The Board of Assessors should be contacted to obtain an application for abatement. The forms are also available on the Assessors' section of the Town's website. The mailing address for the Assessors is PO Box 264, Shutesbury.

Our on-line bill paying feature allows you to pay your tax bills either directly from your checking or savings account with a fee of \$0.25 or with a credit card for a fee based on the amount of your transaction. To use this service, click on the Town's website and then on the announcement on the Home page. For Real Estate and Personal Property taxes, you should enter 2016 for the year and just the bill number WITHOUT the RE or PP to enter the program. For motor vehicle payments, enter the year and bill number which is found on the top, right side of your bill. You are now able to find your bill information by clicking on the notation "Need help locating your bill" after you indicate what type of bill you wish to pay. You then enter your last name and mailing address and click on the bill information.

Shutesbury's leadership met with the leadership of the other three towns in early December 2015 to explain our position and offer a means of transitioning to the Statutory method that would be less extreme. This meeting was emotionally charged and did not generate any meaningful discussion.

An idea to meet again was presented but not acted upon until several days later, when the Amherst Regional superintendent invited representatives from the four towns to another meeting. With only three towns represented at this meeting, the concept was discussed and another plan to transition to the Statutory method was considered.

The superintendent held a second meeting with all four towns present. This meeting concluded with an agreement that starts to move toward an ability-to-pay method. This method is being discussed by the Regional School Committee and a decision to have the new method on the warrant for town meeting should be made sometime in February 2016.

This agreement is a very small step toward what Shutesbury needs. However, there is still much more negotiating required before Shutesbury will be satisfied with the assessment method. Unfortunately, time has run out for any further negotiating to be conducted for this year's (FY17) budget cycle. We are expecting to start talking with the other towns about FY18 early this summer.

What this means for residents of Shutesbury is the Annual Town Meeting warrant article regarding regional assessment may be different this year.

If the Regional School Committee recommends using the method the four towns recently negotiated, the warrant article will be a vote to either use this new Alternative method (Shutesbury assessment amount \$1,700,000) or the Statutory method (Shutesbury assessment amount (\$1,455,000).

If the Regional School Committee does not recommend this new Alternative method, then the warrant article will be a vote between the old Alternative method (Shutesbury assessment amount \$1,727,000) and the Statutory method (Shutesbury assessment amount \$1,455,000).

This is an extremely important issue that you will be resolving at Town

Meeting. There will be more information provided in the next couple of months.

Regarding regionalization: The effort to modify the Amherst-Pelham Regional agreement to create a PreK through 12 region is moving into its fourth year of work. Currently, the draft of the new regional agreement is on the desk of the Regional School Committee. It will soon decide whether to approve the draft and send it to the towns for a vote.

The town vote will consist of two questions. The first will ask town voters whether they approve of amending the regional agreement. The second will ask town voters whether they want to join the new PreK-12 region. Each question has many subtle ramifications depending on a *yes* or *no* vote.

Early in the current process, Shutesbury realized that the proposed plan for regionalization was not beneficial for our town and elementary school. The first question is required since all four towns need to agree on this question in order to make a change to the agreement. If any town doesn't vote to amend the agreement, that will end the approval process of a PreK-12 region.

It has been suggested that Shutesbury should be a good neighbor and let the other towns regionalize but unfortunately, there are significant changes that would be triggered if Shutesbury voted yes and approved amending the regional agreement. These changes would be fundamental to our relationship to, and role in, the regional school district.

An amended agreement would give Shutesbury only two years to decide to join the region.

After two years, Shutesbury would have to apply for membership. The Superintendent would conduct an impact study to determine the effect of allowing Shutesbury to be a member. The Regional School Committee and the Shutesbury School Committee would then negotiate to mitigate any impact Shutesbury would have on the region. After this, the majority of the Regional School Committee would have to approve Shutesbury's membership. More than likely there would be no incentive for the region to allow Shutesbury to join.

Allowing the agreement to be amended, but then not joining the region, would mean Shutesbury would lose its current representation on the

Regional School Committee. Currently the Regional School Committee consists of 9 members: 5 from Amherst, 2 from Pelham, 1 from Leverett, and 1 from Shutesbury.

Under an amended agreement there will be 9 to 13 members: 7 from Amherst, 2 from the towns that are full K-12 members of the region, and 1 from any town that is only a grades 7-12 member. It would be very difficult for Shutesbury to have a voice in this configuration. As it stands, the best option for Shutesbury is to vote no on amending the agreement, and no on joining the PreK-12 region.

Another school issue is the proposal to consolidate the Middle School into the High School. There are still surveys being conducted and studies being completed so nothing definitive is yet at a decision stage, but indications are that financially this would be a smart move for the Region to make.

There are some concerns about this idea, and just like the other school issues, more information will be provided in the near future, so please stay informed.

Collector, cont. from page 6 due to late payment. The date your payment is received in this office or by the lockbox is the date of payment for receipt purposes under Mass. General

If you receive a demand notice, you should pay it immediately as you only have 14 days from the demand date to pay before the bill goes on warrant which results in a substantial increase in the fees.

If you have purchased your property after January 1, 2015, Massachusetts General Law requires that the previous owner's name remain on the real estate tax bill. Hence, your name will appear with an "in care of". There is nothing we can do to put the bill solely in your name.

The question has come up concerning the information found on the bills. All information is required either by Massachusetts General Law or by the Department of Revenue of the Commonwealth. The Town and this office have no discretion on the statements printed thereon.

Before venturing out to pay a bill in person, please call this office at 259-1615 to check the answering machine to determine if I will be here.

Commonwealth Catalog

The M.N. Spear Memorial Library is a member of C/W MARS, a consortium of 140+ libraries with nearly nine million items. If you cannot find what you are looking for in C/W MARS, you can search the collections of many other Massachusetts libraries through the Commonwealth Catalog.

The Commonwealth Catalog gives you access to millions of items from libraries that hold unique collections, such as Boston Public Library and UMass Amherst and other academic, special and public libraries. These items will be delivered to the M.N. Spear Library through the same statewide delivery

system used to deliver C/W MARS items.

You should always search C/W MARS first, through the **Card Catalog** tab on mnspear.org. The Commonwealth Catalog will not accept holds on items available through C/W MARS.

To access the Commonwealth Catalog, follow these easy steps or ask for help at the library.

From the M.N. Spear Memorial Library website, mnspear.org, click on the Commonwealth Catalog Tab This tab takes you to the home page of the Commonwealth Catalog.

On the upper right side of the screen, click **Login**. A Login screen will appear. You need to complete three items on this page. First, select a library. Scroll down to find Shutesbury and choose the M.N. Spear Memorial Library. Next, enter your 14 -digit barcode number. Finally enter your pin. If you do not remember your pin, enter the four digits of your phone number or your last name. Finally, click Submit.

Once you have logged in, you may begin searching for items in the

Commonwealth Catalog. You can begin by entering a title in the box labeled *Enter your search here*, then click the magnifying glass symbol. The check symbol to the right of the search box allows you to modify your search by title, author, subject and more. The tabs under the search box lead to information of the Commonwealth Catalog. Comprehensive instructions for using the catalog can be found by clicking the **Patron FAQ** tab.




Items borrowed through the Commonwealth Catalog can be checked out for 28 days. Renewals are not allowed. Items must be returned at the library where they were picked up.

March 1 deadline to report personal property for FY2017 Businesses and 2nd Homes

The Shutesbury Board of Assessors recently sent notices to all businesses and owners of second homes that a personal property "Form of List" should be completed and returned to the assessors by March 1 2016. Property owned on January 1 is taxable for **the fiscal year 2017 (which starts July 1 2016).**

Business Form of List (State Tax Form 2)

Incorporated and non-incorporated businesses must report all equipment and machinery. In addition, non-incorporated businesses must report inventory such as office furniture, filing cabinets, chairs, adding machines, computers, printers, motorized tools, etc. Farm animals, unregistered motor vehicles and unregistered construction equipment must also be reported. If you depreciate the furnishings on your federal tax return, you or your accountant may already have an itemized list and you could attach that to the Form of List rather than filling out the tables on the form.

Household Form of List (State Tax Form 2HF)

Owners of 2nd homes, duplexes, etc. must report all furnishings and appliances including refrigerators, stoves, dishwashers, washers and driers, TV's, lawnmowers, dishes, eating & cooking utensils, furniture, etc. If you purchased your property furnished, and you were provided with a value for the contents of the home at the time of purchase you may submit that information (copy of purchase and sale agreement, appraisal, etc.) by attaching it to the form of list. If your property is insured, the insurance company should be able to provide you with a list of the contents and their insured value OR a lump sum value for all of the contents. You may attach a letter from your insurance company or a copy of your insurance coverage page to the Form of List rather than filling out the tables on the form.

Exemptions

Exemptions exist for veterans with service related disabilities and their wives, widows, and for elderly residents of Shutesbury. The criteria for elderly are listed below. Gross income is subject to a Social Security exemption allowance (i.e. we do not include this amount) of \$4,523 for the retired worker if single and an additional \$2,262 for his or her spouse. Total household income must be verifiable by tax returns and/or earnings statements. Assets include all bank accounts, IRA's, stocks, investments, personal property, and real estate excluding primary residence.

CPA exemption information

The Community Preservation Act (CPA) is a surcharge which is added to the property tax to support local conservation and/or development projects. Depending on the owners' household income, they may be eligible for an exemption from the tax.

The following tables show the allowable net household income to qualify for the CPA exemption. These tables are based on an area wide median income of \$74,300 from HUD*.

Applications for the CPA exemption must be accompanied with copies of the federal income tax return for 2014 and received by assessors no later than March 30.

Motor vehicle excise tax

This is about the time of year for excise taxes for calendar 2016 to be mailed to owners of vehicles.

In order to receive an abatement the owner **must** document **two** things.

- 1. Return of the license plate
- 2. Transfer ownership of the vehicle

If you have sold or traded a vehicle recently and received a tax bill for that vehicle you can apply for an abatement for a portion of the year. We will issue a pro-rated abatement upon receipt of all materials required by law.

- Bill of sale (if sold) or trade in documentation (if traded), or handwritten bill of sale.
- Plate return receipt or copy of new car registration showing plate transfer.

Application forms are available online for download at www.shutesbury.org/assessor.

You may leave the form and documents in the Assessor's mailbox in the Town Hall or mail it to Assessors at P.O. Box 264, Shutesbury MA 01072. We will process your abatement promptly upon receipt of the above materials.


