Pole Survey Update:

- 36% done; would have been done by end of month but not sure because of the snow and it's taking extra time to shovel out the poles
- Focus on the pole survey applications- cost is less if we provide them with additional information such as photos/ additional distance on lowest sag point (Osmosis is doing this)- but only applies to the Eversource poles of which account for less than 5% of our poles.

Gayle emailing with Jim Hemmingway; want to hold a joint meeting to do a deep dive of the build and operations numbers; they want to do a full eval of sustainability- updates include: 1) depreciation reserve no longer needed- just do for the electronics and not the fiber, 2) new ISP provider amounts (worked with Crocker numbers but now we also have other estimates like OTT, WG&E). Focus of the meetings: 1) Operating cost of OTT, WG&E, WW, 2) Detailed build cost and budget (rough estimates). Will follow up in late April since FinComm is too busy until after Town Meeting

Steve, Craig, and Eric to review the budget numbers - rough out the budget - have it ready by end of next week to review on 3/27 Gayle and Craig to touch base on 3/24 re: how the budget is looking
