here the work we've done over the winter to prepare for our new fiscal year.

Of course, all that has been overshadowed by joining with all Town boards and

committees to deal with the COVID-19 crisis and trying to manage the effect on our community. We all would like answers. We're all concerned. Hopefully, we're all practicing good hygiene, wearing cloth masks if and when we go into public areas, and practicing social distancing: staying at least six feet apart and congregating in no greater than 10 people per group. Together we will show the strength of our community bonds and we will come through this crisis.

For now, your best source of information is the Town Announce email system and checking for updates on the town website. If you have not signed up for Town Announce go to the shutesbury.org website today and sign up in the right-hand corner.

If you have children attending Shutesbury Elementary School who are on the free and reduced lunch program there is food assistance for you. The school sends out weekly information. While they are not at the school, you can email them with your questions.

If either you or someone you know needs help at this time, please contact the Fire Depart-

ment, the Police
Department or the
Town Administrator. They will help
you find assistance
to get through. For
those of you who
want to help and
don't know how,
local grocery

stores' gift cards can be purchased and sent to either the school, the Fire Department or the Police Department, and they will distribute them to folks in need.

Let us keep our community spirit even though we must stay at a distance. We are fortunate to have open spaces to walk in and wonderful supportive neighbors to wave to. Staying at home is the easiest way to do your part to combat the spread of this disease. Please know that we, your Select Board, are here and working together (remotely) to do everything we can to help.

Now, let's look at what we would have liked to have been telling you that was most important only a few weeks ago.

Your Select Board has been working hard over the winter on preparations for the 2021 budget and Town Meeting; future planning for vulnerability planning; hiring personnel; supporting the annual ice-to-mud transformation of our roads, among many other things.

In February (which seems like a lifetime ago), the Select Board, Finance Committee and School Committee worked together to present a united front to the Regional School Committee to request that we move to using the standard (statutory) assessment method (recommended by the state) with a five-year rolling average of the number of students from each town.

To that aim, the Regional School Committee heard our request and moved toward a more equitable assessment for our town. That means a 3% reduction in our Regional School assessment over last year.

Community Notification System (otherwise known as reverse 911)

As of August 1, 2019, the Town of Shutesbury has been using a service called CodeRED as our emergency community notification system to send important alerts and time-sensitive messages to residents and employees.

#### Important information Regarding Your Tax Bill

Under "An Act to Address Challenges Faced by Municipalities and State Authorities Resulting From COVID-19," Chapter 53 of the Acts of 2020, the town/city has adopted local options to extend due dates for real and personal property tax payments and applications for exemptions and a waiver of interest on certain municipal tax and other bills paid by June 30, 2020. See below.

- The due date of your real and personal property tax bill has been extended to June 1, 2020. June 1, 2020 is the new due date even if the due date for payment on your enclosed or previously mailed tax bill is April 1, 2020 or May 1, 2020.
- 2. The due date for applications for property tax exemptions has also been extended to <u>June 1</u>, <u>2020</u>. June 1, 2020 is the new due date even if the due date for applications on your enclosed or previously mailed tax bill is April 1, 2020.

This extension applies to applications for the exemptions listed in the third paragraph of G.L. c. 59, § 59, including exemptions under clauses 17, 17C, 17C1/2 and 17D (seniors, surviving spouses, minor children of deceased parent); 18 (financial hardship – activated military, age and infirmity); 22, 22A, 22B, 22C, 22D, 22E, 22F and 22H (veterans, surviving spouses and surviving parents); 37 and 37A (blind persons); 41, 41B, 41C and 41C1/2 (seniors); 42 and 43 (surviving spouse and minor children of firefighter/police officer

killed in line of duty); 52 (certain eligible seniors); 53 (certain eligible properties with septic systems); 56 (National Guard and reservists on active duty in foreign countries); and 57 (local option tax rebates). This extension also automatically applies to applications for residential exemptions under G.L. c. 59, § 5C, for small commercial exemptions under G.L. c. 59, § 5I and for deferrals under G.L. c. 59, § 5, clauses 41A (seniors) and 18A (poverty or financial hardship due to change to active military).

Information on exemptions can be found on the Assessor's web page on the Town's website (Shutesbury.org) or by contacting the Assessors by telephone at 413-259-3790 (please leave a message with return telephone number), e-mailing the office at assessors@shutesbury.org or sending written requests to Board of Assessors, PO Box 264, Shutesbury, MA 01072, Applications for exemptions should be mailed to the Assessors at the above address and must be received on or before June 1.

3. The town/city has also voted to waive interest and other penalty for late payment of any excise, tax, betterment assessment or apportionment thereof, water rate or annual sewer use or other charge added to a tax for any payments with a due date on or after March 10, 2020 where payment is made late but BEFORE June 30, 2020. This applies to late payments of bills that have a due date of March 10, 2020 or after, when payment of such bills are received at the Collector's office before June 30. This waiver of interest does not apply to bills with due dates before March 10, 2020 or if payment of the bill is not received at the Collector's office by June 30.

This waiver only applies to the following bills: 2020 Real Estate and Personal Property Quarter 4, 2020, Motor Vehicle excise commitment 2 (bills number 1792 -1888), commitment 20 (bills 20001-20019) or any bills not yet issued. It does not apply to any overdue balance on the quarter 4 real estate or personal property bills.

**NOTE - If the municipal offices** are closed on the June 1, 2020 extended due date for tax payments or filing of exemption applications as a result of the outbreak of the 2019 novel coronavirus or the declaration of a state of emergency issued by the governor on March 10, 2020, the due dates for tax payments and applications for exemptions are not extended they will be due on June 1, 2020 even if the municipal offices are closed. (See section **10(b) of the Act.)** 

Messages can be left for the Collector at 413-259-1615 with return telephone numbers (return calls will be made mornings only) by e-mail to collector@shutesbury.org and by mail to PO Box 175, Shutesbury, MA 01072. Payments can be made through the UniBank on-line banking site. The link is found on the Town's website (Shutesbury.org). To enter your information, you should enter the vear and bill number without letters (ie 2020 for year and 165 for bill number) or click on "to search for your bill - click here" and enter the last name of the first name on the bill. Payments can be mailed either to the lockbox at Town of Shutesbury, Department 3520, PO Box 4110, Woburn, MA 01888-4110 or Town Collector, PO Box 175, Shutesbury, MA 01072. No payments can be made in person at the town hall as the town hall is closed to the public.

#### **TOWN ELECTIONS:**

Legislation has increased opportunities for **Absentee Voting or Early Voting by mail for town elections**.

Step 1. Request a ballot. Requests for ballots can be sent in now. Ballots will be mailed out starting May 1, 2020.

Send a **signed**, written request (mailed or emailed), to the Town Clerk stating residential address, type of ballot being requested (Absentee or Early) and where to mail it. Or download either application form (AV here) or (EV here). Emailing a jpeg of your signed letter or application is also acceptable. Once your request is received, we will mail you a ballot, a ballot envelope (with affidavit and signature line) and an envelope in which to mail the ballot to Town Hall.

step 2. Sign an affidavit. Early and Absentee <u>ballots</u> are exactly the same. The <u>affidavits</u> to sign on the envelope differ slightly. The Absentee Voter affirms they are a registered voter in Shutesbury using an absentee ballot because they will be absent from town on election day or are unable to vote due to a disability (now including the COVID-19 precautions) or religious belief.

The Early Voter signs affidavit affirming they are a registered Shutesbury voter but does not swear to any specific reason.

Your ballot affidavit envelope must be signed in order to be counted.

Step 3. Seal the ballot inside the signed envelope and put that envelope into the mailing envelope provided by the town. *One* first class stamp is all the postage needed. All mailed ballots must reach the Town Clerk by noon on June 27.

The legislation still requires the opportunity to vote in person on Election Day, June 27. The polls will be open from 8am to 2pm. Social distancing may still be required. Annual Town Meeting will convene at 9am. The location for both events is the Shutesbury Elementary School, 23 West Pelham Rd. If any of these plans are modified, an announcement will be made on the town website, www.shutesbury.org.

CENSUS: LOCAL and FEDERAL On Monday, June 1, state law requires postcards be mailed out, inactivating those who never returned this year's TOWN census form. You can reactivate your voting status by sending in the post-card or returning the census form. If you need a new census form, please contact the Town Clerk's office.

The 2020 FEDERAL census affects funding and representation for all of us in Shutesbury. As of this date, only 50% of Shutesbury has returned the Federal census forms. Unfortunately, no one with a Post Office Box address received their census letter since the government must mail or hand deliver the form to a verified residence. The strategy for census workers to drop off a packet is temporarily suspended. Here is some information about how to overcome this obstacle:

### Households that have not yet received anything yet about the 2020 Census have three options:

(1) Wait for the 2020 Census letter and survey packet to be dropped off at the household in the future. Households will have until August 14, 2020 to self-respond. **OR** 

(2) Go online to <a href="https://www.my2020census.gov">www.my2020census.gov</a> and complete the survey without using a 12-digit Census ID. When asked to log in, click on "If you do not have a Census ID, click here." The next page will ask for the address of where you were living on April 1, 2020. Then submit your address accordingly. **OR**(3) Call 844-330-2020 to com-

(3) Call 844-330-2020 to complete the survey by phone without using a 12-digit Census ID. You will provide your address over the phone. For more information on how to respond by phone, including the phone numbers to call to complete the survey in 15 other languages and TDD, go

to: https://2020census.gov/en/ ways-to-respond/responding-by -phone.html.

Do not worry if you fill out the survey online or by phone now, and then forget and fill out the paper form later. The Census Bureau has a process to review households that submitted multiple responses.

Also, a question that has come up for some households that received their invitation letter in the mail: What if the town or zip code listed in the mailing address does not match the town where I actually live? The mailing address does not impact the data collected. The Census ID number on the 2020 Census invitation letter is geo-coded to the physical location of the household. The mailing address is only used to get the invitation letter from the Census Bureau to the household efficiently.

#### **DOG LICENSES**

The new 2020 – 21 Dog licenses are in. The current tags expire June 30, 2020, but you can get new ones now. You do not need to fill out an application if you have no changes from last year. You may send in the fee and a selfaddressed envelope with TWO first class stamps and we'll mail out your new dog(s) tag. If you have changes to report, you can download the application and mail it in with your check and return envelope. If you need assistance, please call or email the Town Clerk.

#### **ALL OTHER BUSINESS**

In addition to voter registration, elections and dog tags, the Town Clerk still handles vital record requests, DBA Business Certificates, marriage intentions, notary services, oaths of office, and public record requests via email and phone.

Through hard work by former Select Board member and current Planning Board member **Michael DeChiara**, we obtained a \$16,000 Municipal Vulnerability Preparedness Grant. We have hired Fuss and O'Neill to work with the town to help determine our greatest needs. The focus includes looking at the effects of climate change on our community. They will work with us to help the town identify our vulnerabilities and strengths in managing and dealing with the possible changes ahead due to climate change.

The Select Board has also been working with the Finance Committee in preparation for our Annual Town Meeting. The work is continuing, though Town Meeting has been postponed to the last Saturday in June (6/27/2020) because of the COVID-19 virus and the directives from our Governor limiting the number of people who can congregate.

Our last in-person meeting was on 3/17/2020 at the Town Hall. At that meeting the Select Board declared a State of Emergency, which, among other things, allows us to be reimbursed for emergency-related expenses. The Select Board discussed the need for citizens to use Town Announce and check the Town Website for updates and information. We also are using our new reverse-911 system, Code Red, Announcement capacity to let people know of the changes occurring during this unprecedented situation.

On 3/17/2020 the Selectboard voted to change Town Meeting from the last Saturday in April to June 27, 2020 for this year.

Our Town Clerk, **Susie Mosher**, is working with the State on final plans as to how to hold our Town Elections this year. This information will be on the Town Website. Should the State of Emergency still be in effect at the end of June, the Select Board will work on

alternatives to holding a live meeting. At this time, however, the assumption is that we will be meeting at the Shutesbury Elementary School.

Through this emergency, our Board of Health is central to managing any response to the COVID-19 virus and has been incredibly competent, professional and efficient in their response. They are working closely with the state officials. They regularly post updates and useful information on our town website, www.shutesbury.org. The Select Board supports their actions and their on-going work.

All Board and Committee meetings in town are now held on the Internet using the "Zoom" platform.

Gayle Huntress, MLP Manager, gave a training to all town officials. Information regarding meetings and how to access them through the "Zoom" Platform is available on the town website. Meetings are recorded and can be viewed upon request to the Town Clerk. Of course, meeting minutes will continue to be posted in a timely fashion on the town website.

Having Broadband Internet through this time has enabled those of us who can to work from home; our students to work on school work remotely; people to connect through the various video platforms available; and many other things. It's hard to imagine how difficult this all would be if we were using the old satellite, DSL or dial-up systems. Thank you all who helped make Shutesbury.net possible! When you see Broadband Committee members traveling through town, give them a wave or honk to show your gratitude.

With people at home, and (at six feet apart) walking on our trails or on our roads, there is a sense that we are all in this together, how important we are to each other and that through all this we will, as a community, thrive.

### Restoration ahead for war memorial, gravestones

#### News from the **Shutesbury Community Preservation Committee**

The Shutesbury Community Preservation Committee held a public hearing, as per the Community Preservation Act, in the Shutesbury Town Hall meeting room on Thursday, March 12, 2020.

This annual informational hearing is designed to allow public input into the committee regarding town needs and suggestions about how the committee can best address those needs.

This year, the Committee received one project proposal from the Amherst Pelham Regional School, for a schematic design and engineering study for the restoration/reconstruction of the high school track and field.

If approved at our Annual Town Meeting in June, the costs for this project will be proportionately shared by the four towns.

As the CPC discussed ideas for worthwhile community preservation projects, it recognized that each successful project depends on a group of committed volunteers to organize the project, to complete a thorough application and see it through the review process, and to oversee implementation through project completion.

The committee actively encourages groups of volunteers to exercise their creativity and devote their energies to organizing and proposing projects that benefit all of our citizens.

We welcome projects, both large and small, that add to our cultural heritage while providing resources for open space, recreation, community housing and historic preservation.

The Community Preservation Committee thanks the citizens of Shutesbury for their continuing interest, contributions, and support for our community's preservation projects.

Along with emergency and critical messages, the CodeRED

notification system can also be used to notify the community about important but non-emergency information, such as road closures and trash collection schedule changes and other services.

#### What do you have to do?

If you received notifications from our old system, "Blackboard Connect," you are most likely in the new systems data base.

But if you have recently changed your phone number, cell phone number, email address, or if you switched from a Verizon line to a voice over IP line, this change most likely will not be in the system and you will not receive notifications on the devices or via email.

If you are **new to town**, you most likely are not in the system and will not receive any notifications.

Regardless of which category you fit into, all residents are encouraged to visit the CodeRED website and either sign up or update your information. To do this, go to the town website www.shutesbury.org, on the right hand side of the main page, under the picture of Town Hall, click on the link that says "Sign up for notifications." This brings you to a page that has links to sign up for "CodeRED," the Town email list and "My Town Government." Click on the link for "CodeRED" and follow the instructions on the introductory page. From there you can also download the "CodeRED" app. to your smart phone.

For those that like to do things from your cell phone, coming very soon is a "Text to enroll" feature.

We also have a paper application form that can be filled out and returned to the Fire Chief who can input this information for you. This form can be obtained at the Fire Station or there are a stack of them in the Post Office front entry. You can return them by mailing to the Fire Department, P.O. Box 295, Shutesbury, MA 01072 or return in person to the Fire Station.

However it is done, the most

important thing is to get your updated information into the system!

One very important change that should be noted will be the "Caller ID" that shows on your telephone.

In this day and age when we are inundated with "Robo Calls," many of us will not answer the phone if we do not recognize the number. I myself tend to do the same thing. With this new system you will no longer see the number for the Fire Station on your Caller ID. You will now see the following displayed:

For emergency notifications you will see 866-419-5000 or Emergency Comm.

For general non-emergency notifications you will see 855-969-4636 or General Comm.

Please copy these numbers down and place them next to your phone so that you can more easily recognize them. Initial tests have shown that some people have received some variation of the above information on their Caller ID. Please become familiar with what comes up on your phone so you can recognize and not ignore these potentially important calls.

It would also be a good idea to add these numbers to your contact list on your cell phones under the name CodeRED to make them more easily recognized.

One very handy new feature is the fact that if you missed the call and would like to hear the last message delivered to your phone, simply dial the number back and you will be able to replay the message.



### West Cemetery project nears next phase

The Cemetery Commission is presently issuing an RFB (Request for Bid) for gravestone monument restoration at the West Cemetery, for work to be done this year. We have a list of the 18 highest priority monuments for restoration, based on the concern for the safety of the public when they are near these stones, and overall condition.

Town Meeting approved Community Preservation Act funding for this project a few years ago, which also included removal in the oldest section of some very large pine trees that were damaging gravestones with their falling branches. The tree work has been done and we are ready for the next phase.

If you happen to be in the back part of the West Cemetery you may notice metal rods painted red with pink flagging.

These mark the high priority monuments for restoration by a professional. Please be careful around these and all gravestones.

Another important part of this project is a workshop for volunteers, to train them on how to safely and correctly clean gravestones. # Planning a project? Contact the Conservation Commission *before* you start

Thinking of your warm-weather projects? Outdoor projects of any kind may be subject to review to ensure we are protecting Shutesbury's wetlands.

Check before you dig! Landscaping, construction, new structures or even upgrading existing structures may require action to guarantee there will be no impact to nearby wetlands. The Shutesbury Conservation Commission (ConCom) will help.

The ConCom wants to help property owners proceed with their projects while simultaneously protecting the valuable wetland resources that benefit everyone.

Why it matters: Wetlands maintain water quality and serve as critical habitats. They are vital for a healthy ecosystem. Countless critters, from amphibians to birds, depend on wetlands for food, shelter, and spawning. Massachusetts law protects wetlands and infractions are subject to penalties.

Projects you should consider: New landscaping, tree removal, new structures, retrofitting and new septic systems, stormwater drainage on your property, grading or excavation, or that new bocce court you've been dreaming of.

Who to contact: Our knowledgeable clerk, Linda Avis Scott, is there to help you through the process. She can help you determine what you need to do and how to go about it. Here are ways to engage:

1. Call 413-259-3792 and leave

- a message, or email concom@shutesbury.org.
- 2. Visit Town Hall during Linda's office hours: Tuesdays and Thursdays from 10am to 12pm. You can also pick up an informative brochure at Town Hall for more details. (Town Hall is closed during the State of Emergency please email or leave a phone message)
- 3. Attend one of our meetings (from March to October, on the 2<sup>nd</sup> and 4<sup>th</sup> Thursdays at 7pm and from November to February, on the 2<sup>nd</sup> Thursday). It's best to call first to get on our agenda.
- For more information about the work of the Commission visit our webpage at www.shutesbury.org/concom.

#### What Else to Know:

- The ConCom must sign off on all Building Permit Applications whenever digging is required.
- Near Lake Wyola, most proposed work must be reviewed by the ConCom before work begins.
- Don't wait till until your contractor is scheduled to contact us!
   It may take time to schedule a site visit by ConCom, and more time if wetlands are nearby.

We need Volunteers! Do you love the unique natural beauty of Shutesbury? Would you like to help the town protect and nurture it? We currently have two vacancies and are actively seeking interested community members to fill them. We are a group of volunteers responsible for protecting the town's natural resources. We meet one to two Thursday evenings per month and conduct site visits all over town, administer the Massachusetts Wetland Protection Act and the town's General Wetlands Protection Bylaw, and manage town conservation land.

If you think this type of work might be for you, contact Linda and arrange to attend a meeting to see firsthand what ConCom is all about.

In light of the current situation with schools closing, people being encouraged to work from home and public entertainment options illadvised, our Town broadband network seems like a very timely and opportune asset. We wanted to give you some more information about how your Broadband Committee has prepared to ensure the stability and reliability of our town broadband network.

Here's how we have prepared:

- Plenty of bandwidth: We have the capacity for 3X the amount of bandwidth (this means the data capacity flowing to our network from the larger Internet) than what we use during peak times. Gigabit speed to each house means all members in your household can be online simultaneously with no data caps.
- Dedicated repair truck and crew. Our regular maintenance contract includes a dedicated truck and crew to be available for Shutesbury always, even during severe weather or other adverse events.
- 3. Backup bandwidth and a redundant connection: If our primary source of backhaul (again, this means the connection to the larger Internet) should go down for any reason we have a totally separate source and failsafe switchover to keep our network up and running. We also have a dedicated generator to keep the network running in the case of power outages.
- 4. Independent connections to the Internet. This means our back-

- haul connections (see above) are not dependent on companies like Comcast, Charter, Verizon, etc. If their networks get overwhelmed it will not affect us (unless the overwhelm is a global one, of course).
- 5. Automated 24/7/365 monitoring. Our whole network is monitored constantly and remotely for any problems or outages. All this was already in place when our network was built but we wanted to assure everyone that we've put a lot of thought into making sure our network is safe and reliable as possible for all of us. We know it won't do anything to fix the current situation but we thought some assurance about your new network during this time of uncertainty would be welcome.

P.S. Don't forget about telehealth! Telehealth means "visiting" your healthcare provider from the comfort of your home for non-urgent healthcare needs rather than visiting a healthcare facility or clinic. This is done using an Internet connection and video calling. You and your doctor can see, hear and talk to each other on the computer screen from your respective locations.

Here's how it works: First, ask your healthcare provider if they offer telehealth options. If not, ask your insurance carrier if telehealth is included in your plan and how to use the service. It might mean you'll need to see someone different than your regular health care provider.

If you can get the service, you'll get an appointment time and at that time you will follow the instructions they give you for going to a special website to log in. You will need to have a computer, iPad, laptop, phone or other device that has video and audio capabilities. Your provider may alternately offer phone only (no video) consultations if you don't have that technology available to you.

After a discussion of your symptoms and needs. the doctor will make a diagnosis and suggest follow up care, such as calling in a prescription for you. It may seem unusual that your health care provider can make a diagnosis from afar, but telehealth has been used successfully in this manner for years.

If a diagnosis can not be made remotely, your doctor may decide that further tests are needed. Your doctor will give you additional instructions such as visiting a lab, clinic or office as the next step.

By law your consultation should be private and secure. The provider offering the service will have more information about this if you have questions.

### From the Assessors' Office

Kevin Rudden, *Administrative Assessor* 

Bringing broadband to Shutesbury has made a big difference to the town in a way you may not realize. According to local realtors, having broadband has put the town on home-buyers' radar screens.

Since Massachusetts requires properties to be assessed at full and fair market value, part of the Assessors' job is keeping up with real estate market trends. After just over 30 single-family home sales took place in Shutesbury last year, I interviewed local realtors last month to find out why so many people are moving here.

The main reason is that – before broadband – Shutesbury just wasn't on people's radar screens. Now that we have it, the other two reasons kick in: the lack of housing inventory in other communities within the greater Amherst area and the recent booming real estate market due to low interest rates.

Compared with area communities, Shutesbury's available real estate is considered to be one of the best values in the region, especially for families looking for a school system with a good elementary school and the higher grades being part of the Amherst school system.

Most of the recent sales were above the current assessed values because Shutesbury's housing prices were low when the town was not being considered due to the lack of broadband. Now, homes priced between \$200,000 and \$400,000 are selling quite well.

Even with a temporary market slump beginning in March due to fears about the COVID-19 coronavirus, local realtors expect the market for homes in Shutesbury to rebound later this year.

For the foreseeable future, any necessary home inspections will be done on an exterior basis only - unless the homeowner requests and/or agrees to an interior inspection.

Board of Assessors meetings will take place through web conferencing, per Governor Charlie Baker's March 10, 2020 Executive Order.

### Note from the Town Collector

Ellen McKay, Tax Collector

Dear Shutesbury taxpayers,

With the Town Hall being closed to the public for the foreseeable future, please be advised that you will not be able to come in to drop payments in the box outside my office or to pay bills in person. Please mail the payments to Town Collector, PO Box 175, Shutesbury, MA 01072. If you have any questions on your bill, please call this office (413-259-1615) mornings, leave a message if calling any other time or e-mail me at collector@shutesbury.org.

Due to the time it takes for mail delivery, it is imperative that you PLAN ACCORDINGLY when mailing your payments. Under Mass. General Law, we do NOT use the postmark for date of payment but rather the date of actual receipt. You should mail bills at least ONE WEEK before they are due to insure that they are received before the due date.

If you use on-line banking from your bank (not the Town's system) and mail it to the lockbox in Woburn, please be aware that the bill will come to this office for processing from the lockbox because it is not accompanied by a copy of the bill. To make certain the payment is received on time, please change the mailing address to Town Collector, PO Box 175, Shutesbury, MA 01072-0175. This will eliminate the bill going to the lockbox and being forwarded.

PLEASE make sure the memo information is correct and does not reflect information from previous payments (ie: listing real estate or excise bill numbers from previous years or an incorrect type of bill). Since your bill payment is NOT an automatic transfer into the Town's bank account, you must PLAN ACCORDINGLY when authorizing the payment. DO NOT set up the payment on the due date, it won't get to the Town until almost a week

later which will result in fees and interest

Your fourth quarter real estate taxes are now due June 1. I urge you to pay these bills promptly, as the next bill you will be receiving is a demand that will cost you an additional \$5 plus interest. If you need to set up a payment arrangement on your bill, please contact me as soon as possible. Although interest will accrue on any overdue portion of the bill, you will avoid the additional interest and any collection procedures beyond the demand that will accrue should you leave the entire bill unpaid.

Don't forget to contact the Board of Assessors if you no longer have a vehicle on which you have received a motor vehicle excise tax bill. All bills should be paid in full before you apply for abatement. If this is not done and the bill becomes overdue with additional fees and interest before abatement, these must be paid along with any outstanding balance due on the bill after abatement.

Payment of all types of bills MUST be received on or before the due date which is clearly marked on the bill. Please make note of these dates and make your payments accordingly. Always open all envelopes you receive from this office immediately on receipt. The bill you think is a real estate bill (and paid by your bank) may be an excise tax bill for which you are responsible.

Be sure to notify this office if you change your mailing address to avoid a delay in delivery of your mail which is returned to me for forwarding. This can take as much as two weeks which reduces the time you have to pay the bill on time.

Should a demand bill be issued on a motor vehicle excise tax, the law provides 14 days for receipt of payment before a warrant for collection is issued to the Deputy Collector. This results in at least \$22 in additional fees. Upon mailing of the demand bills, payment of

### Council on Aging places programs on hold

Due to the COVID-19 pandemic and the resulting needs for social distancing, the Council on Aging (COA) has suspended until further notice the following services for town residents age 55 and over:

- The Med Ride Program, which matches volunteer drivers with Shutesbury seniors do not need a walker or wheelchair, but who are unable to drive or have no means of transportation to medical and dental appointments
- The Foot Clinic, which brings a registered Food Care Specialist to Town Hall once a month to serve residents by appointment
- Community Pot-lunches, held monthly at Town Hall in the Senior Lounge and open to all.

At its April 8, 2020 meeting, conducted via Zoom, the COA voted to fund a possible online yoga class should the M. N. Spear Memorial Library offer one in the future.

# Developmental screenings for 3, 4, and 5 year olds in the community

In Shutesbury, developmental screening is available through the school as a first step in a process intended to find children in need of special services and to plan for meeting those needs.

Screening focuses on a child's

growth in a number of areas, such as large and small muscle control, speech/language development and concept development. This activity takes about 20 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of whether or not a child's skills are developing within the typical range.


A **StoryWalk** is an outdoor reading experience of a children's book which has been deconstructed with the pages placed on signboards along the walking trail or in this case, around a field.

For many years now, the Friends have organized "Spring Spruce-Up," a season-long event that brings teams of library enthusiasts to neighbors' doors. In exchange for a donation to the Friends' New Library Fund, the teams provide sponsors with one hour of yard work. Spruce-Ups not only provide opportunities for helpers and sponsors to support our important cause, but also strengthens community connectionneighbors meeting and working together, perhaps getting outside and getting dirty, and beautifying our town, one yard at a time.

At the beginning of the COVID-19 crisis, we were hopeful we could find a way to execute this year's Spring Spruce-Ups. But the virus is more serious than anyone expected and social distancing is the most important thing any of us can do right now.


This year, Library Giving Day, a national event, is scheduled for Thursday, April 23. The Friends of the Library have decided to forego participation this year.
