Moderator Musings

Even after 40 years of attending - and more recently, presiding over - Shutesbury's Town Meetings, I still find certain aspects of parliamentary procedure to be confusing or subjective. I'd like to address one of those in this issue, but first, an announcement: A vacancy has recently opened on the Finance Committee that I plan on filling prior to July 1 (i.e., the start of the new fiscal year). If you'd like to be considered for the vacancy, please email me by June 1 at Moderator@Shutesbury.org with a statement of your interest. Now, on to the exciting stuff – parliamentary procedure! An important role that the Moderator plays at Town Meetings is

2023 Annual Town Meeting (and in-person voting for Election of Officers) Saturday, June 3 determining when a motion or an amendment is "outside the scope" of an article. And oftentimes, that's not a straightforward call. Here's some background: When the Warrant (the "agenda") for a Town Meeting is posted (which by law, has to happen at least 7 days before the meeting), it serves as an "adequate warning" to voters about what topics will be discussed and voted on at that meeting. Such notice allows voters to prepare for the meeting (maybe by studying the budget proposal, reviewing the wording of a proposed bylaw change, or reading through committee meeting minutes), or they might decide that those topics are not important enough for them to miss their child's soccer game. So, it's important that the wording of the warrant articles provides enough detail to give voters a good idea of the types of decisions that are likely to be made at the meeting.

But, by design, that wording usually isn't so specific that Town Meeting doesn't have some "flexibility" in deciding the specifics of the matter.

(That's why the phrase "or take any other action relative thereto" is often included at the end of the article wording.) The specifics are generally spelled out in the actual **motion** that is presented on the floor of Town Meeting for an article, and/or in proposed amendments. But, the motion or amendments cannot deviate too much from the wording in the posted article.

Here's an example: Let's say that a warrant article proposes that the town spend \$25,000 on a sedan for the town's tree warden. On the floor of Town Meeting, a motion might be made to transfer \$25,000 from Stabilization for the purchase of a 2-wheel drive sedan. But someone might argue that the tree warden really needs a 4-wheel drive vehicle, which would cost \$27,000, and further, that the money should be taken from Free Cash rather than Stabilization. Those are reasonable changes that would likely be allowed (i.e., considered "within scope"). But a proposed amendment to spend

Moderator, cont. from page 1 \$50,000 on a HumVee would likely be ruled "out of scope," because it's substantially different from the article wording, and also because a voter who chose not to attend the meeting could effectively argue that he/she did not receive "adequate warning" that such a purchase might be approved at the meeting. Here are a couple other "out of scope" examples: 1) A motion to amend a zoning bylaw would not be permissible under an article to repeal the bylaw; 2) An amendment to include funds for a new recycling shed would not be within the scope of an article to improve handicapped access at the school.

In Moderator parlance, questions about Scope are usually thought of in terms of a "Four Corners" perspective. That is, "Does the proposed change fall within the bounds. or four corners, of the intent, purpose and wording of the article?" Such determinations often involve on-the-spot judgement calls, which are not always easy. And different Moderators may very well rule differently on similar questions of scope. In the end, it's just one more reason why New England Town Meetings are so wonderfully intriguing and entertaining – and worth attending!

I'm just gonna dive right into it. "It" meaning the civic info you need to know.

Annual Town Meeting will take place on Saturday, June 3. in the field behind Town Hall at 1 Cooleyville Rd. As we've been doing the past few years, Town Meeting will occur outside. If you have comfortable portable chairs at home, consider bringing them to sit in. If you have any mobility concerns with navigating the grass, please contact the Town Clerk or Town Administrator so we can make sure there is seating available for you at the edge of the lawn.

The Annual Local Election will also be taking place on June 3 at Town Hall, inside and downstairs. Polls will open at 8am and close at 2pm. You can vote in person at Town Hall on June 3, and you can vote by mail. The deadline to apply for Vote by Mail is May 30 but between us, that deadline is a little unrealistic. USPS recommends allowing 7 days for the mailing of your ballot. So, please keep that in mind if you are applying for Vote by Mail. All ballots must be received by 2pm on June 3 in order to be counted.

I have many years of municipal experience ranging from serving on the Shutesbury school and finance committees and for 3 years serving as a shared town administrator in four Franklin County towns.





News from your Select Board

Your Selectboard members, Rita Farrell, Melissa Makepeace O'Neil and Eric Stocker, have been busy tending to town business over the last few months.

The Town is continuing our site investigation of Lot O-32 with our licensed site professionals at Fuss and O'Neill to ensure that all environmental concerns are addressed at the future site of the library. Most recently, additional test wells were installed at the site of the former air force tower. Discussions are underway with the Army Corps of Engineers regarding their responsibility for cleanup of the contamination at this location.

A Public Involvement Plan (PIP) has been drafted to address how the Town will work with local citizens on the planning and remediation at Lot 0-32, the site of the future library. The draft PIP will be finalized after comments are incorporated into the final document which will be done by the end of May.

Planning is well underway for the design for the replacement of the school roof and we expect to put the roof out to bid in time to allocate funds at Annual Town Meeting on Saturday, June 3.

The other big construction project for this year will be the replacement of the culvert on Locks Pond Road adjacent to Lake Wyola. This project will commence in mid-July and will result in Locks Pond Road closure and detours.

In other Lake Wyola news, the Select Board is in the process of developing a draft by-law to limit access to the dam at Lake Wyola due to safety concerns. This by-law will go before Annual Town Meeting this June.

The Town has been notified that it is eligible for the Clean Water Trust Emergency Loan Program for PFAS remediation. The loan would cover the costs associated with the FAS contamination at the fire station and households affected by this contamination, which totals just over \$136.000. The loan would be a 0% interest 20 year loan and there is a good chance of forgiveness for part of the loan. All the costs associated with the engineering, POETS systems, filters and any additional testing would be covered. There will be an article on the Town Meeting warrant to authorize the Town to apply for this loan.

We continue to hold our bi-weekly meetings on Zoom Tuesday evenings at 5:30 – always check the town calendar for updates and the meeting agendas. And don't forget: Town Meeting will be on Saturday, June 3, at 9 am under the tent behind town hall. We look forward to seeing you there.



Prevent Outages

After both the January and March snowstorms this year,

we enacted our emergency response plan for the first time since the network was built. Both of these storms were severe enough that large percentages of the homes in town lost power, some for multiple days, and dozens of homes had their broadband lines or equipment damaged. After each storm our new service provider deployed a small fleet of trucks and technicians to Shutesbury and had almost everyone back online within 48 hours. We know how critical the internet is when these storms roll through for you to stay connected to loved ones, school, work, and entertainment.

Almost all of the damage to our network happened on the drops — the fiber lines that run from the road to each home. Here's what YOU can do to help ensure your connection stays online during the next storm.

- Clear Hazard Trees:
 Make sure tree limbs
 and vines are trimmed
 away from the fiber lines
 that run from the road to
 your home and remove
 any deadfall that could
 be hazardous to the
 wires. Please consider
 having this work done
 this spring! Since tree
 work near wires entails
 personal safety risks, we
 recommend you consult
 with a professional.
- Install Surge Protectors:
 Plug your in-home
 broadband equipment
 into a surge protector
 instead of directly into a
 wall socket. Electrical
 surges and cycles like

what we had with the March storm can damage your equipment, and surge protectors will help prevent this.

Consider a Battery Backup: The batteries included with the Cyberpower UPS (Uninterruptible Power Supply) battery backup units that were sold during initial installation are reaching the end of their 3-5 year lifespan. If yours has failed, or you never got one, you might consider getting a new battery (or UPS battery backup unit) so you can continue to have phone service during a power outage. Larger battery backups can also supply your router and other devices with power so you can stay online on the internet during a power outage. Lastly, make sure your driveway is plowed and downed trees are cleared as soon as possible when you have an outage so repair trucks can get through. And please shovel a pathway to the fiber network equipment on the side of your home so technicians can reach it.

Early Childhood Program The Shutesbury Elementary School (SES) Community believes that

opportunities for early childhood education are essential components of a good education system. Early experiences in an environment rich in hands-on materials and activities provide children various opportunities to grow emotionally, physically, socially and cognitively. We believe that a trans-disciplinary team approach, in which all adults working with children are responsible for a child's learning, is the most effective way of teaching, and we also believe that parents are the most important teachers of their children and that their involvement in their child's education is essential.

Update from the Library **Building Committee**

The Library Building committee is now engaged in the schematic design phase.

Our three main priorities are usable space with minimal cost, to site the building within all the wetland constraints on the property, and 3. to build a net zero energy building.

Where did that leave us? Our architects (Odens – Ello) gave us three designs to choose from. Two were rectangular buildings with similar interiors but different orientations, and the third was an L-shaped design.

After much discussion, tours of many other libraries in Massachusetts, and hearing from the community at our public forum, we chose the design of the rectangular building with a single south sloping roof. This will maximize placement of solar panels, maximize interior usable space, and minimize cost.

We had detailed schematic designs presented to us at our May 16 meeting. We are currently getting cost estimates on the options.

We appreciate everyone who attended our public forum. We have received many thoughtful comments and yes, criticisms. We know we can't accommodate all ideas brought forth. That said, we still want to hear them. We will be presenting our next phase in a public forum sometime in the summer. You are most welcome to attend our bi-weekly meetings where we always hold the first 10 minutes

Means-tested senior citizen property tax exemption comes to Shurtesbury! From the Board of Assessors

The June 12, 2021 Annual Town Meeting authorized the Select Board to petition the General Court for passage of a special law to provide for a means-tested senior citizen property tax exemption.

This exemption is tied to the applicant's qualification for the Massachusetts State Tax Form Schedule CB (Circuit Breaker). Governor Charles Baker approved and signed Shutesbury's special request on November 7, 2022, allowing qualifying senior citizens to benefit from this exemption in the coming Fiscal 2024 tax year.

Assessors are developing an information sheet detailing qualifications and an application form. The application forms will be available by July 2023 and the return deadline will likely be August 31, 2023. Any senior citizen of Shutesbury, who qualified for the state "Circuit Breaker" Form Schedule CB, who is 65 years of age or older, and who has owned a home in the Town of Shutesbury for not less than 10 consecutive years may be eligible, based on their calendar 2022 income and assets.

If you wish to receive an information sheet and application form, as soon as they are avail-

able, please email your request to: assessor@shutesbury.org, or mail your application request to: Shutesbury Assessors, P O Box 264, Shutesbury MA 01072. Please include your name, your email address (if available), your mailing address, and a telephone number.

This exemption would be in addition to the long-standing statutory exemptions and applications that were re-voted and up-dated at the May 21, 2022 Annual Town meeting, and which are due each April 1.

The Massachusetts Department of Revenue (DOR)
requires that Assessors visit
each parcel in their community
during every 10-year period, in
order to verify that interior and
exterior information on file for
each property is accurate. This
requirement is meant to ensure
that each property is valued fairly and equitably. It is a critical
element in developing uniform
and fair market values.

Such routine inspections are called "cyclical inspections." Recent construction and property sales also trigger DOR required property inspections, and may double as a "cyclical" inspection for a 10-year period. For practical reasons, much of the Shutesbury Assessors' inspection work is done during the fair-weather seasons, as are coming up soon.

Assessors schedule interior inspections at the convenience of the property owner. In the absence of interior opportunities, Assessors minimally conduct exterior inspections, which may include verification of decks and outbuildings, measurements, and an updated exterior property photo, all in keeping with DOR

standards and expectations. Should you have any special requests concerning a property inspection, Assessors invite you to call 413-259-3790, or email assessor@shutesbury.org anytime to leave a message. We look forward to working with you to properly follow DOR guidelines, while respecting your needs and wishes. Thank you in advance for your cooperative understanding.

Note from the Town Collector

Dear Shutesbury taxpayers, Happy spring! Now that the warmer weather is approaching, we are nearly at the end of fiscal 2023 and the Town Meeting for fiscal 2024.

IMPORTANT NOTICE: As I have had to change vendor programs, all bills generated after June 1 will appear different than the current ones. All information on the bills will be the same as on the present ones but in different places on the bill. The top section is the collector's copy of the bill, the middle has the information that is currently found on the back of your bills, and the bottom section is the copy for you to keep. If you want a receipt, please send the entire bill (or the top and bottom sections) with a self-addressed, stamped envelope. My office hours are Monday, Tuesday, Wednesday and Friday from 9 am - Noon and Thursday from 8 – 11 am. If you call during these hours and I don't answer, please leave a message. I'm either on the telephone or have stepped out of

the office.

Always open all envelopes you receive from this office immediately upon receipt. The bill you think is a real estate bill (and paid by your bank) may be an excise tax bill for which you are responsible.

If you use on-line banking from your bank (not the Town's system), please change the mailing address to Town Collector, PO Box 175, Shutesbury, MA 01072 -0175. Please make sure the memo information is correct and does not reflect information from previous payments (ie: listing real estate or excise bill numbers from previous years or an incorrect type of bill). Since your bill payment is NOT an automatic transfer into the Town's bank account, you must plan accordingly when authorizing the payment. DO NOT set up the payment on the due date as it won't get to the Town until almost a week later which will result in fees and interest.

If you are having financial difficulty paying your real estate bills, please contact me to arrange a payment plan.

Don't forget to contact the Board of Assessors if you no longer have a vehicle on which you have received a motor vehicle excise tax bill. All bills should be paid in full before you apply for the abatement. If this is not done and the bill becomes overdue with additional fees and interest before abatement, these must be paid along with any outstanding balance due on the bill after abatement.

Be sure to notify this office if you

permanently change your mailing address to avoid a delay in delivery of your mail which is returned to me for forwarding. This can take as much as three weeks which reduces the time you have to pay the bill on time. I am glad to forward bills if you are temporarily away. However, I must know this is the situation before you leave to avoid the bills being returned as "temporarily away" by the post office, which delays delivery to you.

Should a demand bill be issued on a motor vehicle excise tax. the law provides 14 days for receipt of payment before a warrant for collection is issued to the Deputy Collector. This results in at least \$22.00 in additional fees. Upon mailing of the demand bills, payment of the original bill will NOT be accepted and checks made out in the incorrect amount WILL be returned to the sender.

Some of you have been unable to pay your bills on-line. If the bill is on warrant, it cannot be paid on-line except through the Deputy Collector's office which can be reached during business hours at 413-527-2388.



The Library Loans Kayaks!


