

A vital message from the Board of Health Catherine Hilton, *Chair* 

Some numbers: Between spring 2020 and January 19, 2022, there were 113 known cases of COVID-19 in Shutesbury residents. More than half of these cases – 69 of them – were reported in the month prior to January 19. Seventeen of these cases were self-reported, the results of positive home testing.

### If you or a household member get a positive result on a home test, know what to do:

1. <u>Inform your health care</u> <u>provider</u> of this result.

2. Inform the Board of Health at <u>publichealth@shutesbury.org</u> so that we can provide you with information and guidance.

Age-Friendly Communities Project seeks your input! LifePath, our Area Agency on Aging, has launched a survey of Franklin County and the North Quabbin in collaboration with the Franklin Regional Council of Governments, senior centers and Councils on Aging (COAs), including Shutesbury's COA.

The survey, for residents over 50 years old as well as caregivers of older adults, is the main component of the age-friendly needs assessment process, which seeks to better understand the challenges facing seniors in our region. Responses will remain confidential. They will be used to help create an Age-Friendly Action

3. Begin isolating right away, including from members of your own household if they have not tested positive. The vast preponderance of cases are transmitted within households or at family gatherings. You must wear a mask around others, even in your own home. The guidance on isolation and quarantine has evolved: if you test positive you must stay home, in isolation, for five days, not 10 days as previously. After five days, if you have no further symptoms and feel well, you can resume your life but you must continue to wear a high-quality mask, ideally N-95, KN-95, or KF-94, whenever you are around other people for five more days.

Guidance about masks has also evolved. The most important

New program may help lower that broadband bill Gail Huntress, *Chair, Broadband* — *ShutesburyNET* 

The federal relief program to reduce monthly internet bills ended in December, but it has been replaced by a new longterm program called the Affordable Connectivity Program (ACP).

This program, available to ShutesburyNET subscribers who meet certain income requirements, can reduce your monthly bill by almost \$40 if combined with the long-standing Lifeline program.

Only one single application is needed to determine financial eligibility for both programs.

There are 155 people in Shutesbury who still have not requested to have their \$49 WiredWest deposit returned. Because the money is held in an escrow account, *you must make the request individually, and in writing,* to get your deposit back.

**Dog Tags:** Have a pupper or doggo? Check to make sure their license is up to date! The easiest way to do this is by checking the color of their Shutesbury dog tag. If the tag is not blue, you can get a new dog tag application at Town Hall or on the Town Clerk webpage.

**Staying Connected:** While visiting <u>shutesbury.org</u>, remember to sign up for the **Town Announce mailing list!** This is the best way to receive important information and updates from town officials. And if you think you are already signed up but have not been receiving emails recently, check your spam folder. And if you have not already done so, please sign up for **CodeRED** to receive emergency alerts from town government.

thing about a mask is that it must be properly adjusted and fit you. Air should go through the mask, not around it. That said, **cloth masks have been found to be far less effective than N-95 masks** in preventing the spread of the omicron variant.

Please note that many masks that claim to be N-95 masks do not, in fact, filter at least 95% of airborne particles, because of either poor quality control or fraudulent claims. To make sure the masks you contemplate buying are approved, go to <u>shutesbury.org/</u> <u>pandemic-information</u> and click on <u>CDC-approved masks</u>.

Rapid test kits are now covered by insurance at pharmacies; in addition, free test kits can be ordered from <u>www.covidtests.gov/</u>. If you do not have internet access and wish to order tests, contact the Board of Health for help.

Keep informed! If you are not receiving regular e-mail updates from the Board of Health, you're missing out. It's easy to get on the list for town announcements: go to the town website, <u>shutesbury.org</u>. At the bottom of the home page, on the right, click on <u>Sign up to re-</u> <u>ceive email Town Announcements</u>. It won't be a flood of unwanted emails; most weeks there are one or two. If you think you signed up but aren't receiving any messages, please check your spam folder.

### Select Board seeks volunteers 'energized' for climate action Hello Residents.

Given the identified threats to the community from climate change and the need to address how energy policies and programs could help to mitigate the effects of that change through municipal and community efforts, the Select Board recently reconfigured the Shutesbury Energy Committee to create the Energy and Climate Action Committee.

To this end, the Select Board is reaching out to the community for letters of interest to be part of this new committee. Below is a full description of the background, purpose, composition and charge.

### Revised Energy Committee Charge Draft, 11/9/21

### Background:

The Shutesbury Energy Committee has been in existence for more than 44 years and was established to take advantage of Green Communities funding opportunities i.e., solar panels, energy audits, and conservation measures. In April of 2018 the Shutesbury Select Board voted to revise the charge of the Shutesbury Energy committee to "The purpose of the committee is to study and recommend to the Select Board, in coordination with other committees: energy policies, approaches and projects on efficiency, conservation and generation for the benefit of the town and residents."

Since 2018 there have been a number of steps taken by the Town to address issues related to the effects of climate change. This includes the adoption of the Municipal Vulnerability Plan, which includes a comprehensive, baseline climate change and natural hazard vulnerability assessment and a list of priority actions for the Town. In addition, the Town updated its Hazard Mitigation Plan which identifies actions to be taken to reduce or eliminate long-term risk to people and property from natural hazards such as flooding, storms, high winds, hurricanes, wildfires, earthquakes, etc.

### **Purpose:**

The Energy and Climate Action Committee (ECAC) shall make recommendations to the Select Board on ways for the Town to meet its climate mitigation and resilience goals as detailed in the Town's 2020 Municipal Vulnerability Plan (MVP) and the 2021 Hazard Mitigation Plans (HMP).

### **Composition:**

Seven (7) voting members appointed by the Shutesbury Select Board, some of whom shall have experience with one or more of the following areas: net zero energy building; energy efficient retrofits; climate change mitigation/ advocacy/research; clean energy practice/policy/infrastructure; community choice energy; green infrastructure for climate adaptation; sustainable transportation; sustainable farming and forestry; waste reduction; and environmental or climate justice, and other relevant areas.

### Charge:

The ECAC shall:

1. Study and make recommendations energy policies, approaches and projects on efficiency, conservation and generation for the benefit of the town and residents 2. Review and prioritize recommendations from Shutesbury's Municipal Vulnerability and Hazard Mitigation plans.

3. Recommend for adoption to the Select Board target dates,

benchmarks and/or climate mitigation goals to achieve
4. Coordinate with other town committees' and boards' efforts to develop a plan to reduce
Shutesbury's energy footprint and to build climate resilience.
5. Recommend to the Select
Board programs and policies to implement energy goals and climate resilience planning in such areas as, but not limited to:

- a) Energy;
- b) Built environment;
- c) Transportation;
- d) Land use;
- e) Water;
- f) Solid waste;
- g) Infrastructure; and
- h) Open space, agriculture and forestry

6. Report progress to Select Board on a quarterly basis

# From the Administrative Assessor

### Tax exemption applications:

Applications for tax exemptions for veterans and senior citizens who meet certain criteria continue to be available from the Assessor's Office through the end of March. You can find out more about them by scrolling toward the bottom of the "Assessors" page found under "Departments" on the town's website.

Among the exemptions available to the **military veterans** who have served our country are those know as Clause 22 (\$400), 22A (\$750), 22B (\$1,250), 22C (\$1,500) 22D (complete exemption), 22E (\$1,000) and 22F (complete exemption). The term "clause" and its associated number/letter refers to the section of Chapter 59, Section 5 of the Massachusetts General Laws authorizing these exemptions.

Among the exemptions available to **senior citizens** are those known as Clause 41 (\$500), 41B (\$500), 41C (\$500) and 41 C  $\frac{1}{2}$  (5% of the average assessed

valuation of residential property in town).

**Circuit Breaker State Income Tax Credit:** When filling out their state income tax return forms for calendar year 2021 this year, **Shutesbury's seniors should check to see if they are eligible** to receive what is called the "Massachusetts Senior Circuit Breaker Tax Credit" by filling out Schedule CB.

Not only can eligibility save you money on your state income taxes, but qualifying means you will be eligible for the town's <u>Means-</u> <u>Tested Real Estate Property Tax</u> Exemption "METER," which Shutesbury can offer once the state legislature passes the home-rule petition authorized at our 2021 Annual Town Meeting.

**Updating Exemptions:** Most of the tax exemptions enacted by the state legislature are decades old. Only a few have been updated. The Assessor's Office is reviewing all of them and will put forward acceptance of any updates on this year's Annual Town Meeting warrant.

Auto Excise Taxes: It's that time again. The Registry of Motor Vehicles just sent its first (and usually largest) batch of motor vehicle excise tax data so that cities and towns across the state can send out annual auto excise tax bills to you.

Two things to remember: First, all data on the bill is generated by the Registry. If there is an error, you need to contact the Registry, not the Town.

Second, this includes the value of your car. The Registry uses the manufacturer's suggested retail price (MSRP) as its value, not what you paid for it.

The value is calculated on a declining scale as follows: 90% of MSRP in year one; 60% in year two; 40% in year three; 25% in year four; and, 10% in year five and older.

### Note from the Town Collector Ellen McKay, *Town Collector*

Dear Shutesbury taxpayers,

With the winter upon us, the third quarter of our real estate bills are due on February 1 and the calendar 2022 motor vehicle excise bills for many vehicles registered on January 1 have been mailed. Additionally, excise bills on vehicles registered late in 2021 are billed during 2022. The year for which the bill is issued is found in the upper right hand corner of the bill.

For everyone with an Amherst or New Salem mailing address, please check your registration to make certain the "Place of Garaging" is listed as Shutesbury. This is the information the Registry of Motor Vehicles uses in determining what municipality issues the excise tax bill. If you find incorrect information on that line, please contact the Registry and your insurance company to correct the information.

If you receive a bill on a car you have traded or on which you have changed registrations, do NOT ignore the bill. The Board of Assessors should be contacted to obtain an application for abatement. The forms are also available through the Assessors' section of the Town's website and should be printed out in landscape format for easy completion. The mailing address for the Assessors is PO Box 264, Shutesbury.

Our on-line bill paying feature allows you to pay your tax bills either directly from your checking or savings account with a fee of \$.50 or with a credit card for a fee based on the amount of your transaction. To use this service, click on the Town's website and then on the announcement on the Home page.

For Real Estate and Personal Property taxes, you should enter 2022 for the year and just the bill number WITHOUT the RE or PP to enter the program.

For motor vehicle payments, enter the year and bill number which is found on the top right side of your bill. If you do not have this information, you are able to find your bill information by clicking on the notation "Need help locating your bill" after you indicate what type of bill you wish to pay. You then enter your last name and all bills in that name should be shown. Select the correct one and click on it and the amount due will appear.

Please note that the on-line feature cannot be used to pay any bill on warrant.

PLEASE PLAN AHEAD when mailing your tax payments to avoid interest due to late payment. The date your payment is received in this office or by the lockbox is the date of payment for receipt purposes under Mass. General Law. If you send a check generated through a bill payment function from your banking institution, please note that it may take over a week for the Town to receive the payment. If you have the bill generated on the payment due date it will definitely be late. Please address these checks to the Collector's Shutesbury mailing address which is PO Box 175, Shutesbury, MA 01072. Do NOT use the Woburn address because the lockbox cannot process the payment because there is no bill enclosed, which results in the check being forwarded to Shutesbury and additional time elapsing before you payment is recorded.

If you receive a demand notice, you should pay it immediately, as you only have 14 days from the demand date to pay before the bill goes on warrant, which results in a substantial increase in the fees.

If you have purchased your property after January 1, 2021, Massachusetts General Law requires that the previous owner's name remain on the real estate tax bill. Hence, your name will appear with an "in care of." There is nothing we can do to put the bill solely in your name.

The question has come up concerning the information found on the bills. All information is required either by Massachusetts General

### Ruminations of a Shutesbury 'Newbie' Paul Lyons, *Town Moderator*

This year marks four decades since my wife and I moved to Shutesbury and built our first home here. That feels like a long time ago, but I know better than to consider myself anything other than a relative newbie in town!

But although I have not yet earned the right to talk about "the way things used to be," I have still witnessed a lot of change, and I've learned a fair amount about our town during that time.

First and foremost, I've seen that there are a lot of really good people living in Shutesbury – many of whom give of themselves in various ways as volunteers to keep our town running.

Just imagine if we had to <u>pay</u> people each year to develop our budget proposals, administer wetland protection regulations, research and develop our zoning bylaws, oversee public health regulations, plan and oversee construction of our broadband network, evaluate the condition and needs of our town buildings, edit our newsletter, run our recycling program, apply for grants, and all the other vital town functions that volunteers perform!

Not all of us are called, or we may not be able, to volunteer on town

### committees, but we can all still have a say in the most important decisions affecting our town. That's because the work that those committees and boards (and town employees) do all year long usually culminates in warrant articles that are discussed and voted on at our Town Meetings. That's the way it's been for hundreds of years, and that's the way it's likely to be for the foreseeable future.

So, why is it that of the 1400+ registered voters living in Shutesbury, less than 200 tend to show up for most Annual Town Meetings to make those important decisions?

As Town Moderator, I ponder and ruminate on that question more than I probably should. But that's because I know that there are many strong opinions in town that are never heard at Town Meetings, yet could add a great deal to the discussions.

It's probably becoming obvious that I tend to let some discussions continue at Town Meetings longer than some (many?) of you would like. And that's because on some issues, I know that there are opinions and perspectives that have not yet been expressed, but might be helpful for all of us to hear before we cast our votes. So, for the sake of "fully informed decision making," I allow those discussions to continue a bit longer.

But sometimes, those other perspectives are never heard – perhaps because the people holding them aren't even present. And that's what I'd like to understand better – i.e., Why do some people with strong opinions on town matters choose not to show up at the one place where they have the best opportunity to express their opinions, and perhaps influence the outcome of votes?

No doubt, there are a number of possible reasons why this may be the case, but if there happens to be some commonality among those individual reasons that I/we might be able to do something about (e.g., to make Town Meeting more welcoming and comfortable for people), then THAT'S what I want to know.

So . . . although I generally don't like to solicit emails to the Moderator's account, in this case, I <u>would</u> like to hear from any Shutesbury voting resident who does NOT generally attend Town Meeting and would be willing to tell me (completely confidentially) why you don't. Or, if anyone has thoughts or ideas (within reason of course) on how Town Meetings could be made more welcoming, I would appreciate hearing from you also. For legal reasons, it can't be done as a group request or sent to you automatically. If you want to support the advocacy work that Wired-West continues to do for broadband throughout the state, you can request that your deposit be donated into their general funds instead of being refunded to you.

If you don't either request a refund or donate your deposit in writing to Wired West, the funds will be forfeited to the State's general funds in April of 2022.

# Out and about with the Recreation Committee

The Community Garden is coming! It just has a longer gestational period than we expected.

The original intent was to create the garden behind Town Hall.

While the location had the advantage of convenience and

visibility to those going to Town Hall, it also had disadvantages, among them the need for a water tank (not the most attractive structures) and increased parking congestion and traffic behind Town Hall.

Meanwhile, two sites were under consideration for the proposed library: behind Town Hall and Lot 0-32 (on Leverett Road), and in November 2021, Lot 0-32 was selected. While locating the gardens at this site will delay the garden's start, integrating the community gardens into the landscape around the library creates exciting opportunities for collaboration. We had always envisioned the garden as a place for educational programming and building community, and this proximity makes both possible.

### Updates from the Council on Aging

The Council on Aging (COA) serves town residents aged 55 and older.

**Big news!** In early January, our COA was notified that Shutesbury's application to enroll in AARP's Network of Age-Friendly Communities was officially accepted. We are now part of a network of local and regional communities participating in LifePath's initiative with AARP to "strengthen the features and services that help to make communities livable for residents of all ages."

We are pleased to be participating in this program, and ask you to complete the "Age-Friendly Communities Survey" described on page 1 of this newsletter. Although it is a regional survey, we will be able to review Shutesbury's own data, which will help us understand the needs of our older residents. All submissions are anonymous.

### New LifePath/Community Action **Older Adult Home Modification** Program

This program is designed to help eligible homeowners, 62 years of age and older, to remain in their homes through no-cost modifications that reduce the risk of falling, improve general safety, and increase accessibility. Modification examples include installation of grab bars, railings, lever handled door knobs and faucets, and safety bathroom/tub equipment.

Because 2021 Town Meeting approved the use of CPA funds for a garden specifically located behind Town Hall, we will be returning to Town Meeting in June 2022 to request to locate the community garden on Lot 0-32.

We project that the community 2024. So a long gestational period! Outdoes the rhinoceros at 15 to 18 months, and even elephants at up to 22 months. But it will be worth the wait.

We will plan programming around sustainable gardening, and beginning in Winter 2023, we will sponsor workshops on planning a garden, knowing when and how to plant seeds, and selecting seedlings so that prospective gardeners have the knowledge they need to dig right in come Spring 2024.

But that's not all! Beyond the garden project, the Recreation Committee has been busy developing a host of new activities for 2022.

We will be working with a Springfield business to purchase reduced-cost, gently used ice skates for children and teens and holding an ice-skating party.

And look forward to a spring Family Track and Field Day to be held at the elementary school track and to guided nature walks.

Everyone is welcome to attend our committee meetings on the 4<sup>th</sup> Tuesday of every month at 4 pm. There's so much happening!



Community Preservation projects for Town Meeting The state Community Preservation Act allows Massachusetts communities to create a local **Community Preservation Fund** to help fund open space protection, historic preservation, affordable housing and outdoor recreation. Community preservation monies are raised locally through the imposition of a surcharge on the tax levy against real property, and these local funds are matched in part by state funding.

CPC-funded projects are community-initiated. The application and funding process is straightforward and is described in the Community Preservation Plan available on the CPC website (shutesbury.org/community preservation). It should be noted that the CPC does not independently appropriate funding for projects, but rather submits warrant articles for funding of allowable projects to Town Meeting for its approval.

This year, the CPC will be presenting four articles at Annual Town Meeting for funding. For you gardeners out there, one of the articles is to allow the Recreation Committee to move the Community Garden (funding approved at last Town Meeting) from its previously approved site behind Town Hall to Lot O-32 on Leverett Road. This article does not affect the original funding and is offered in light of the likelihood that a new library will be situated on Lot O-32.

A second article, sponsored by the Shutesbury Historical Commission, seeks to repair and restore the historic mile guidepost on the Town Common. This antique guidepost has significant historic value and requires restoration work to protect it from further degradation.

A third article, supported by the Recreation Committee, requests funding for the Kestrel Land Trust to slightly expand the existing public parking area at Ames Pond and to resurface it with pervious material. The project will also improve trail access, remove invasive plant species, add a new viewing platform, and make the area wheelchair accessible.

The final article, supported by the Conservation Commission, seeks support for the Kestrel Trust to purchase 34 acres of forested land with 2,000 feet of frontage on Pelham Hill Road. The parcel, which runs from just south of Baker Road to the Pelham line, has high conservation value and is situated between two parcels of alreadyprotected land. It includes the headwaters of Amethyst Brook and features a historic dam/mill structure. The property would be preserved as open space and developed for passive recreation.

Check before you dig! From the Shutesbury Conservation Commission

What we do: The Conservation Commission (ConCom) administers the Massachusetts Wetland Protection Act and the Town's General Wetlands Protection Bylaw. We also manage Town conservation land, educate the public, and work with other town boards and committees to support the environment and open spaces.

Why it matters: Wetlands maintain water quality and serve as critical habitats. They are vital for a healthy ecosystem. Countless critters, from amphibians to birds, depend on wetlands for food, shelter, and spawning. Massachusetts law and our local Bylaw pro-

'Green burial' is an option in Shutesbury The Cemetery Commission frequently fields questions about green burial, which is an option available to residents in a specified area at the West Cemetery.

You can find information about cemetery plots and Shutesbury's green burial guidelines at the Cemetery Commission page at <u>shutesbury.org</u>. Because of high demand, priority for green burial tect wetlands, and infractions are subject to penalties.

**Planning a project?** Check before you dig! Near Lake Wyola, streams and rivers, and many smaller wetland areas in our community, proposed work must be reviewed by the ConCom before the work begins. Landscaping, construction, tree removals, paving, new structures or even upgrading existing structures all may require action to guarantee there will be no impact to nearby wetlands. The ConCom must sign off on all Building Permit Applications when digging is required.

The ConCom wants to help property owners proceed with their projects while simultaneously protecting the valuable wetland resources that benefit everyone. Don't wait till until your contractor is scheduled to contact us! It may take time to schedule a site visit by ConCom, and more time if wetlands are nearby.

There are a variety of smaller projects that may be allowed (or "exempt" from the state wetlands protection regulations) without a permit from the ConCom.

A list of these "minor activities" can be found on the ConCom's homepage on the town website. Our local wetlands Bylaw does not have the same exemptions as the state law. If you are not sure whether you have wetlands on your property or if your project requires a review, the ConCom can answer

### News from the Shutesbury School Committee Dan Hayes, *Chair*

The School Committee has been focused on providing support to administration to insure the safest environment for students, teachers and staff.

Collectively, we all have been following COVID-19 trends, the latest CDC and DESE (Department of Secondary and Elementary Education) guidelines and working with our local Board of Health, in order to stay abreast of critical data and information.

Our goal is to keep students in the classroom — learning, and to protect the teachers and staff so they can provide the best quality education for all students. This has been challenging, especially with cases rising so dramatically; however, patience, kindness and respect are helping all of us manage each hurdle. We appreciate everybody's cooperation and understanding.

The School Committee is also working with the Town's Buildings Committee to address several issues related to building maintenance and repairs.

This includes the recent replacement of the sliding doors that lead into the courtyard and replacement of cracked and heaving sidewalks, as well as exploring remedies for the electrical controls to the heating system.

Additionally, we are prioritizing repairs to the school roof. The roof has been leaking water into the building for several years now; we are very concerned that this could damage the gymnasium floor, and constant water leaking into the building could cause mold and other damage as well. This will be our top priority for the coming year.

The School Committee is also committed to expanding services and opportunities for students, while working with the Finance Committee and Select Board in crafting our budget.

We are continuing to work with Superintendent Jennifer Culkeen, Principal Jackie Mendonsa and our new Director of Finance, Caitlin Sheridan, investigating state and federal monies and grants for relief from the ramifications of COVID-19, including upgrades to the air filtration system, and we have used funds from the school choice account to supplement in areas that support student mental health.

### Preschool and

kindergarten enrollment/ screening for 3-, 4- and 5vear-olds in our community In Shutesbury, developmental screening is available through the school as a first step in a process intended to find children in need of special services and to plan for meeting those needs. The screening focuses on a child's growth in a number of areas, such as large and small muscle control, speech/ language development and concept development. This activity takes about 30 minutes and consists of a number of games that children typically enjoy playing. The screening gives an indication of whether or not a child's skills are developing within the typical range.

Changes to the process of obtaining burning permits Brush burning season started January 15 and runs until May 1. You may no longer call the town's dispatch service, Shelburne Control, for a permit. You must obtain your permit either online at www.fcburnpermits.com or by calling the Shutesbury Fire Station at 413-259-1211. The use of the online service is preferred.

While you can obtain a permit online between 8:30 am - 1 pm on any day that burning is being allowed, you may only call the Shutesbury Fire Station Monday -Thursday from 9 am - 1 pm.

Burning is permitted between the hours of 10 am - 4 pm. Fires need to be out at 4 pm. Burning of brush only. Fires must be attended by a person 18 years or older at all times, and be 75 from any building. Permits are only issued on the day of the intended burning and are good for one day only.
