Review Town Meeting Votes: Both of the Ch. 178 Acts of 2024 HERO Act local option Veteran's benefits were unanimously approved at the May 31, 2025 Annual Town meeting: MGL Ch 59 §5 Cl22I will increase Veterans' benefits each year by the cost of living, and MGL Ch 59 §5 Cl 22J, set by Select Board vote at 100%. These increases will be applied starting in FY 26, and funded out of the overlay account.
