2. Review meeting notes from Gale Assoc. and Contractor meeting.

JQ & BT met with Gale Associates and discussed adding a request for proposal for a piece of flashing behind the PVC that will receive and flash over new material that covers the remainder of the existing fascia. Approved the color of metal flashing to match existing. Contractor is starting from eastside to the south, west then north. Also need to add a scupper box at the base of the valley at the right of the front entry. The replacement of the roof is off to a good start.

3. Review and vote on Gale Assoc proposal for SES repairs/replacement of trim and fascia.

JQ walked around the SES building with Cole from Gale Associates to explain what our goal is. Options were discussed about replacing or covering the "the pink" fascia. Gayle submitted a proposal for Evaluation, Design, Bid Phase and through construction totalling \$78,500. The committee decided to start with the Evaluation Services for

\$9800. Evaluation will include options for replacing or covering the upper fascia and cost estimates. Covering may be the most economical. The committee discussed the totals of Gale's proposal and how we would pay for it with the monies the BC has. The Evaluation will give us a better understanding of the overall scope of the project with options.

JQ motioned to hire Gale Associates for the Evaluation phase for the SES repairs/replacement of trim and fascia. AC 2nds.
