- 1. Meeting Called to order at 7:05pm
- 2. Tim Hunting presented his FY14 budget level funded
 - a. Line marking Tim likes a company who paints the lines at night.
 - b. The 2000 Chevy Pickup is very rusty. It may need replacing next year. (\$40,000) (Capital Planning).
 - c. The 1998 Int. Dump Truck may need replacing in 3 years. (~\$150,000; a stainless steel body would last longer and be more expensive) (Capital Planning).
 - d. Tim is considering spraying Fluid Film undercoating under some of the trucks for added protection, for the cost of about \$100 \$150 per vehicle.
 - e. The new loader is excellent and the new Ford pickup is great too. We ended up trading in the old loader and got \$18,000, reducing the cost of the new loader to \$124,636. The old one cost \$85,000 and ran for 18 years, at the annual average cost of \$4,722.
 - f. He did mention that they could use a vibratory roller. He can rent one and try it. It may help the washboard.
 - g. The bigger towns have washing bays.
 - h. There is a mobile truck washing operation that comes to your site. Eric will send Tim the information.
- 3. Approve the minutes of October 1, 2013 as amended.
- 4. Reviewed the Expense and Revolving funds for FY14.
 - a. The Insurance line may go over. Workers Comp went up 12%. We have a separate policy for Police and Fire insurance. This year the premium went up \$2,700 higher than last year. This line has turned back free cash for 4 years. We may need an additional \$6,000 to cover the expenses we anticipate for this line item.
 - b. Everything else is looking appropriate for the time of this time of year.
 - c. Health Insurance is looking very good at this point. We carry a buffer that equals 2 family policy costs.

5. Vote on Warrants for Special Town Meeting.

- a. **Article 1:** To see if the Town will vote to transfer \$2,977.84 from free cash to pay prior year bill for Hauling Expenses, **approved unanimously**.
- b. **Article 2:** To see if the town will vote to transfer from free cash, \$14,700 to repair the leaking slate roof of the MN Spear Memorial Library, **approved unanimously.**
