# LSTA grant

At its July 11th meeting, the Massachusetts Board of Library Commissioners approved a provisional Innovative grant in the amount of \$15,000 for your Library Services and Technology Act (LSTA) special project. The grant, Toward of Community Culture of Fitness was a collaboration between Rosie Heidkamp and me. The funds will be divided equally between our two libraries and mostly be used to provide fitness related programming.

# About us:

The UMass Amherst Community Campaign (UMACC) is a workplace giving program and employee benefit that makes it easy for employees and retirees to give to any 501 (c)(3) nonprofit that they choose. Many opt to give via payroll deduction which means that pledges are

likely to be fulfilled. This year's UMACC goal is to raise \$450,000. Typically, 60% of what we raise goes to local nonprofits. Over 6000 UMass employees and retirees are eligible to donate through the campaign. This year the campaign will be open between October 22, 2019 and January 31, 2020.

### The MBLC is offering Trustee Orientations this fall.

These sessions are for new library trustees, seasoned board members, and library directors. Trustee Orientations are run by Maura Deedy, Library Advisory Specialist and Rob Favini, Head of Library Advisory & Development.
