GREEN COMMUNITIES DESIGNATION NOT AWARDED TO SHUTESBURY THIS ROUND

Three of the 5 criteria were signed off on for this round. Two were not approved. Criteria 3, 20% Energy Use reduction plan while based on a comprehensive energy audit did not include vehicles. The vehicles must be added. Criteria 4, Policy to Purchase only Fuel-Efficient Vehicles, applies to non-emergency vehicles less than 8500 pounds. All town vehicles are exempt from this requirement currently. The assumption was made that our highway pickup was not exempt. It is 8600 pounds, therefore exempt. This has to be stated in the document. So for Shutesbury, criteria 4, requires an alternative Transportation Demand Management (TDM) document. We have adopted a no idling policy, supported a carpooling campaign, plan for additional parking for commuter use adjacent to the new library, and adopted a 4-day workweek for employees to reduce energy use. The next round for Green Community Designation application will be in the spring. After designation a town is given 2 months to propose the projects they will use their funding for. This delay, while not a good thing, will give us time to better plan for how to best use the funds when we do become designated.

LFNAC members handed off draft 11 of the MBLC grant application to reviewers and Library Trustees today. Thanks to all those who continue, day after day to make this application the best it can be and to those reviewers and Trustees for taking their holiday hours to stay on schedule.

IBEW Local 2324, AG Coakley, and Western Mass towns obtain settlement with Verizon Aaron Goldman is deciphering the details of the settlement language. The press release states that the agreement requires improvements in 33 wire centers serving 65 municipalities by December 31, 2010. It is not yet clear which 33 locations they are talking about. I will share details as they become clear. Thank you to all the folks in Shutesbury who have worked and worked over the years to highlight the need for improvements.
