

The latest on broadband Shutesbury Broadband Committee

All 42 miles of the distribution network (along all the roads) is complete in Shutesbury! Our network went live at the start of this summer.

Concurrently, installations to homes started in June in the Lake Wyola area. Residents who have been connected report they are very happy with their new broadband service.

Throughout town, all prep work for underground installations is on schedule to be done by the end of October before the ground freezes. The "prep work" includes the installation of new underground conduit where needed and running fiber through existing conduit where available. With the prep work completed, people with underground service will be ready for the in-home portion of the installation just like those with above-ground service.

The subscriber campaign in April and May was extremely successful, with over 87% of homes requesting to have service installed. We know every one of the 750 residents who signed up is anxious to get connected, and we're doing everything we can to install as many homes as we can before the end of the year.

When it's your turn you'll get a phone call from Sertex (the installation company) about two weeks ahead to schedule your installation date.



If you don't pick up the call, they will leave a message for you to call back and also email you. We even have a process for coming and knocking on your door if it's difficult to get ahold of you. Nobody who has signed up will be left out!

Don't worry if you see trucks working on your road and you still haven't gotten a call. Installations don't necessarily happen in geographic order.

Please resist the temptation to chat up the installers you see working throughout town unless they are working on your house. Not only does this slow down the work, but they won't be able to answer scheduling questions as that is controlled by their central office. Conservation Commission supports land preservation along Roaring Brook Shutesbury Conservation Commission

Located on either side of Roaring Brook, partway down the S-curves on Leverett Road, is a newly conserved property managed by the Division of Fisheries and Wildlife. The Shutesbury Conservation Commission contributed toward the Division's purchase of a former building lot. A small adjacent parcel was donated to bring the property to a total of four acres. Roaring Brook, which runs through the property, is listed as an important Coldwater Fishery. MassWildlife stocks the stream a little further to the north. The presence of freshwater streams provides valuable habitat for wildlife and the site provides access to the larger Paul C. Jones Working Forest Conservation Easement.

Contained within the site are the extensive remnants of an old sawmill, possibly the oldest in Shutesbury and built in the town's early days. The mill was located between valuable stands of pine timber which may still be seen today. The mill ruins, located not far from the road, are best accessed from the

The Town Clerk's seat will be open next May (I am not running again), and to make the transition as smooth as possible, Grace is working 10 hours a week, learning all the tasks for which town clerks are responsible. The 2020 election year will be very busy, so sharing the information now will be a big help next year.

Her additional hours have increased the regular hours our office is open. We are available for appointments if you can't make it in during the posted hours.

Speaking of busy election years, there will be four elections in 2020 – Presidential Primary on Tuesday, March 3, Annual Town Elections on Saturday, May 2, State Primary on Tuesday, September 15, and THE Election, Tuesday, November 3. If you want to join in counting paper ballots, please contact the Town Clerk's office. We will need many election workers — recruit a friend! There will be information about voter registration on the town website as we swing into 2020.

This summer approximately 70% of the dogs received their NEW GREEN dog tags from owners who got their applications into the Town Clerk office on time. If your dog's tag is expired (6/30/2019) and is sadly without a GREEN tag, you can come to the Town Clerk's office to register or go to the Town

Clerk webpage, print an application and complete the process by mail.

What else do Town Clerks do? Welcome new residents; provide notary services; issue annual dog licenses; handle birth, death, and marriage certificates; administer the annual census; register voters; set up elections; archive Town records; provide public record access; post meeting agendas and minutes; swear-in volunteers and track volunteer paperwork; implement some of our state statutes; provide record information to the state; help distribute trash bags and Leverett Transfer Station stickers; answer questions; and act as a resource reference whenever possible.

Note from the Town Collector

Dear Shutesbury residents:

With the fall approaching, so, too, is the mailing of the next installment of your real estate and personal property taxes. This will occur the end of September with a due date of November 1. If you have paid both the first and second quarter amount with your first quarter payment you will <u>not</u> receive a bill for November. If you do not receive a second quarter bill, please check the middle portion of your first quarter bill as your total bill may be too small to generate a second quarter bill.

If you pay bills with a banking program, please be aware that there is a paper check generated that can take the bank over a week to mail so please plan ahead. It is imperative that you verify the bill number identifier you are using as a memo. Your bill numbers change every year for all types of taxes and your failure to correct the bill number causes difficulty in recording your payment. Please change the mailing address of the check so generated from the Woburn address, which is that of the lockbox, to the Town Collector's address which is PO Box 175, Shutesbury, MA 01072. Because your checks are not accompanied by a bill, the lockbox company sends them to me for processing which results in a delay in crediting them to vour account.

Please plan ahead when you mail your payments as it may take as much as a week for mail to arrive as the post office sorts mail in Connecticut.

Do NOT postdate your checks! I cannot accept such checks because they cannot be processed until the date on the check. They will be returned to you upon receipt.

This lovely spot provides expanded recreational opportunities for the residents of Shutesbury. We encourage town residents to visit!

Parking is very limited. The conserved area is located between 321 and 379 Leverett Road.

In Shutesbury, these appear just above the "U" and the "T" in the town's name. These maps also show that since those times, the locations of some roadways have changed!

is a question we are frequently asked. Under Mass. General Laws, the name of the person who owned property on January 1 of the year in which the fiscal year begins must appear on the bill. In the case of this fiscal year (2020), that date is January 1, 2019. We highlight the "in care of" designation to make certain the bill is delivered to the new owner and not forwarded to the previous owner.

If you will be receiving your mail at a different address during the winter, <u>please</u> notify this office when you will be leaving so I can redirect your bills and ensure that they will be delivered promptly. Please make sure I have your alternate address.

This is also the time to verify all information on your auto registration, license, and insurance documents. Your insurance company furnishes information to the Registry of Motor Vehicles during the last quarter of the calendar year that provides the database from which your motor vehicle excise tax bills on vehicles registered on January 1 are generated. It is essential that the place of garaging and both the mailing and residential addresses are absolutely correct to insure proper and prompt delivery of your bills. If you have an Amherst mailing address, that address should appear as the "mailing address" on your registration so it appears on your excise bill. Failure to have the correct mailing address may cause the bill to be returned as undeliverable and delays delivery.

The Town of Amherst has notified

1832 us that they will NOT be automatically sending bills whose owners reside in Shutesbury but have Amherst mailing addresses to Shutesbury for rebilling. Should you receive a bill incorrectly from Amherst, please make certain all information on your registration is correct. If it is not, contact the Registry of Motor Vehicles (which can be done online or in person) to correct the situation. Once everything is correct, contact the Board of Assessors in Amherst to ascertain what information they need to abate the bill and to send it to Shutesbury. Please start this bill as soon as you receive an incorrect bill as the bill will be due 30 days from the mailing date.

Let me remind you that any tax bill sent from this office should *not* be ignored even if it is on property you no longer own. The Town does not get notified if you dispose of an automobile, turn in your license plates, or dispose of an automobile, turn in your license plates, or dispose of personal property. You must notify the Board of Assessors by completing the appropriate abatement application.

If you move from Shutesbury, please leave a forwarding address and make certain you change your license and registration to indicate your new address and place of garaging. Any registration that lists Shutesbury as a place of garaging will result in an excise tax bill being sent from Shutesbury.

Remember, your unpaid excise bills from any municipality *will* follow you through the data base at the Registry of Motor Vehicles and its compact with other states. Unpaid bills can result in The second secon

your inability to register a vehicle or renew your driver's license and registration.

Shutesbury School Committee updates

The Shutesbury School Committee meets every third Thursday in the conference room at the school. Our role is to set the direction of the school by establishing policies and setting a budget to serve the needs of our students while being responsible to the taxpayers of the town.

Steve Sullivan is our representative to the Amherst Regional Committee. He represents the interests of our Shutesbury students as well as bringing information about issues at the regional schools back to Shutesbury.

Shutesbury is also represented at the Union 28 level by **Dan Hayes**, **Jen Malcolm-Brown**, and **Lauren Thomas-Paquin**.

Katie Fiander and Jen Malcolm-Brown work with Superintendent Jennifer Haggerty and Principal Jackie Mendonsa to review and update policies for SES which they bring to the full committee.

At the Union 28 level, school committee members from all of the represented towns meet to determine the budget for the Central Office of the supervisory union as well as work with Superintendent Haggerty to establish the educational vision for our schools.

Superintendent Jennifer Haggerty offers the following update from Union 28:

This year, we welcome two new principals to Union #28: Lisa Candito at Erving Elementary School and Rhonda Cohen at Leverett Elementary School.

We will continue with our exploration and implementation of Universal Design for Learning in our schools. Universal Design for Learning is a framework to improve and optimize teaching and learning for all people based on scientific insights into how humans learn. The Universal Design for Learning framework guides the design of instructional goals, assessments, methods, and materials that can be customized and adjusted to meet individual needs.

Our schools have been busy preparing for the new school year. Many staff members have been working diligently over the summer to get us ready! We begin with our Opening Day meeting for Union #28 staff on August 26, 2019 at Erving Elementary School. Students begin on August 28, 2019. I look forward to another wonderful year filled with joy and filled with learning.

Dan Hayes serves as the Shutesbury representative to the Collaborative for Education Services, where he is also Chair of the Board of Directors.

The Collaborative for Educational Services (CES) is a non-profit educational service agency, committed to reaching and educating learners of all ages, and experienced in working with educators to help students learn and succeed. They work with districts and communities across the Commonwealth to enhance educational opportunities for children, youth, and adults with a focus on those at risk of failure.

CES directs major initiatives in Early Childhood, Special Education, After School Programs, Professional Development, Educator Licensure, Educational Technology, Social Justice in Education, and the education of vulnerable youth.

Dan has also been appointed to the state's School Transportation Commission, which is examining the demands transportation puts on schools, particularly in rural areas, and how best to address these demands and associated costs.

Like communities across the state, we continue to struggle with decreases in funding and increases in costs. The School Committee works diligently to maintain the exceptional quality of our school while recognizing the financial impacts on our town. The committee is grateful for the continuing support of the community as well as the tremendous efforts of the Shutesbury Elementary School staff to provide our students with an extraordinary education.

The M.N. Spear Memorial Library and the Wendell Free Library were recently awarded a federal Library Services and Technology Act (LSTA) grant for \$15,000 from the Massachusetts Board of Library Commissioners (MBLC). "We are proud to deliver grant funding to libraries for projects that fill unique needs of libraries across Massachusetts." said Rob Favini, Head of Library Advisory and Development at the MBLC. "Libraries continue to be a vital resource to the communities they serve. Programs funded through LSTA grants illustrate the diverse range of topics and audiences served by Massachusetts libraries."

The libraries have planned healthand fitness-related programming over a two-year period, beginning in October 2019.

The MBLC developed this direct grant program using federal funding to help libraries meet local community needs, including programs that help new Americans learn English and become citizens, STEM and STEAM projects, programs that serve teen needs, and projects that preserve valuable historical documents. The MBLC also offers grants to increase access to library services for people with disabilities.

In addition to the direct library grant program, the MBLC uses LSTA funds to support statewide programs and services including summer reading programs, research databases, the statewide eBook program, the Commonwealth Catalog and <u>mass.gov/libraries</u>, which has information and resources for residents.
